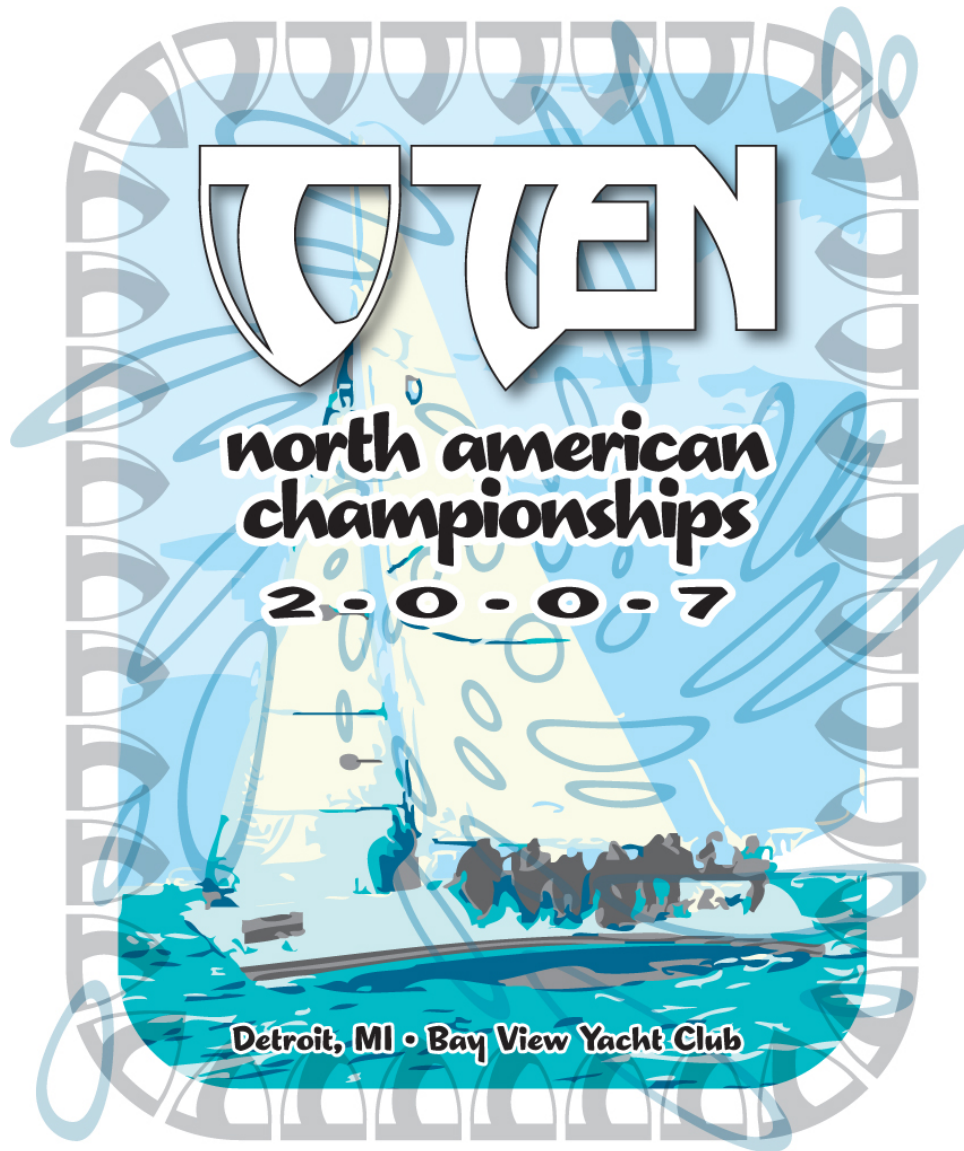


# *Notice Of Race*

*2007 T-10 North American Championship Regatta*

*Aug. 11<sup>th</sup> - Aug 15<sup>th</sup>, 2007*

The T-10 Detroit Fleet is the Organizing Authority for this regatta, in cooperation with the T-10 Class and the Bayview Yacht Club.

## 1. RULES

- 1.1 The T-10 North American Championship (NAC) will be governed by the *rules* as defined in the current Racing Rules of Sailing (RRS) and the T-10 North American Championship Regulations, except as any of these are altered by the Notice of Race or the Sailing Instructions. Where a conflict exists between the NOR and the Sailing Instructions, the Sailing Instructions will govern.
- 1.2 This North American Championships is designated ISAF Category A.
- 1.3 Removable bow numbers of contrasting color shall be attached to both sides of the boat's hull at all times while racing. The stickers are to be attached with the top approximately 8-10" below deck level and with the leading edge approximately 10-12" aft of the bow. Bow stickers will be provided in the Regatta Skipper Package at registration.
- 1.4 Sponsor or other regatta stickers may be required to be attached to each side of each boat as required by the Organizing Authority.

## 2. ELIGIBILITY

- 2.1 All contestants must be eligible in accordance with the Eligibility, Article 6, of the T-10 NAC Regulations.
- 2.2 The yacht shall have a valid Certificate of Measurement.
- 2.3 Proof of ownership in the form of title or registration or proof of charter must be supplied with the entry form.

## 3. ENTRIES

- 3.1 All Entry Forms are due on or before **Thursday, July 31 2007**. Late entries will be accepted until Thursday, Aug. 9<sup>th</sup>, 2007 with an additional \$175 late fee. ***NO ENTRIES WILL BE ACCEPTED AFTER AUG. 9<sup>TH</sup>, 2007.*** Entry Fee (\$350) must be paid via Paypal at the website [www.yachtscoring.com/emenu.cfm?eid=124](http://www.yachtscoring.com/emenu.cfm?eid=124) or by check sent to the *2007 North American Championship, c/o Wolverine Inflatables, P.O. - 3.2 Entry Forms are available in the NOR Package, as well as on the event website at [www.yachtscoring.com/emenu.cfm?eid=124](http://www.yachtscoring.com/emenu.cfm?eid=124) or call Hanson Bratton (248) 640-4407 and/or [hrbj@aol.com](mailto:hrbj@aol.com).
- 3.3 All Eligible yachts may enter the Regatta by submitting the following: Entry Fee, Official Entry Form, valid Certificate of Measurement, Proof of Ownership or Charter (title or state registration) and Certificate of Insurance with minimum \$300,000 liability coverage. *Entry Fee and Official Entry Form must be submitted by Thursday July 31, 2007 or by Thursday, Aug. 9<sup>th</sup>, 2007 (additional late fee applies). All other forms are required no later than registration.*

## 4. REGISTRATION & MEASUREMENT

- 4.1 Registration will be conducted at Bayview Yacht Club on Friday, Aug 10<sup>th</sup>, 2007, 12pmEST – 6pmEST and on Saturday, Aug. 11<sup>h</sup>, 2007, 8amEST – 6pm EST. The Sailing Instructions will be made available at registration. Amendments to the Notice of Race or Sailing Instructions will be posted on the Official Notice Board by 0800 EST daily.
- 4.2 Crew lists, weight, and waivers, Inspections and Sail Measurement Registration will be conducted at or before Registration. Crew lists, weight and waivers, Measurement Certificates, Certificate of Insurance, Proof of Ownership, Required Equipment list and payment of any other fees shall be completed in order to register.

- 4.3 In addition to Sail Measurement, the NAC Regatta Measurement Staff may inspect and measure any “measurable” item of any yacht.
- 4.4 Consistent with Regulation 7 of the T-10 Class NAC Regulations, the crew list will identify all persons pre-registered as crew. Each boat may present additional alternate crew members who may be substituted as permitted under NAC Regulation 7.1. Each boat shall sail with the all persons pre-registered as crew. Crew substitution is limited to a person from the alternate crew listed and weighed at registration and only by application to and with the permission of the Championship Committee or the Board of Directors.
5. LAUNCHING
- 5.1 Launching and haul out will be provided for all T-10’s at Bayview Yacht Club. Boats requesting to be launched and/or hauled out must make arrangements prior to Aug. 4<sup>th</sup>, 2007 with Doug Scheibner at (248) 227-0630.
- 5.2 No haul outs during the Regatta with the exception of emergency repairs approved by a NAC Judge.
6. BERTHING
- 6.1 Berthing shall be at the Bayview Yacht Club and assigned by the 2007 NAC Dockmaster. All regatta participants MUST dock at the Bayview Yacht Club unless prior approval and arrangement have been made with the 2007 NAC Dockmaster.
7. SAILING INSTRUCTIONS
- 7.1 Sailing Instructions shall be provided upon completion of Registration at the Bayview Yacht Club.
- 7.2 Preliminary Sailing Instructions which may or may not be the finalized copy, will be available for the Practice Race on Saturday, Aug. 11<sup>th</sup>, 2007.
8. RACING AREA
- Racing area will be on the waters of Lake St. Clair and detailed in the Sailing Instructions.
9. SCHEDULE and EVENTS
- Number of races in accordance with the T-10 NAC Regatta Regulations Article 10, revised 06/18/07. In general, 3 races per day are scheduled for the first 3 days and 2 races are scheduled for the final day, although at the discretion of the Race Committee the number of races each day can be increased or decreased depending upon the conditions and/or whether a sufficient number of races have been completed to constitute a series.

Courses and Course length shall be in accordance with the T-10 NAC Regatta Regulation Article 11, revised 06/18/07.

#### 11. SCORING

11.1 The NAC regatta shall be scored as per the Low-Point Scoring System of the RRS Appendix A. However, no score will be excluded as provided by RRS Appendix A2.

#### 12. PRIZES

12.1 Prizes shall be awarded in accordance with the T-10 NAC Regatta Regulations Article 3.

12.2 Prizes will be awarded for yachts placing first through third in each race, and first through fifth Overall in the Regatta. Prizes will be awarded each day of racing.

12.3 The Perpetual Trophies will be presented at the Closing Ceremony.

12.4 Other special trophies may be awarded.
