SAILING INSTRUCTIONS AMENDMENT #1

*THE FOLLOWING CHANGES TO THE SAILING INSTRUCTIONS ARE VALID FOR THE LEVIN MEMORIAL CUP **ONLY***

1 RULES

SI 1.10 is replaced with:

1.10. Appendix T1 will be in effect. Appendix T1(b) is changed so that the post-race penalty shall be 20% if the number of racing yachts is greater than 15, if all other conditions are met. A post race penalty may be requested by filling out a scoring inquiry on the Yachtscoring web site with the details of the incident (race, location, other boat) and stating that it is desired to take the T1 penalty. 5 SCHEDULE SI 5.1 is replaced with: 5.1. Registration will be On-Line only and must be completed (including payment) by 0930 hours the first day of the event. 15 PROTESTS AND REQUEST FOR REDRESS: SI 15.1 is replaced with: 15.1 Protests and requests for redress or reopening shall be delivered Online on Yachtscoring by logging into the owner's corner and filling out the online form. SI 15.3 is replaced with:

5 SCHEDULE

SI 5.1 is replaced with:

5.1. Registration will be On-Line only and must be completed (including payment) by 0930 hours the first day of the event.

SI 5.2 is replaced with:

5.2. All regatta documents will need to be downloaded by the participants from Yachtscoring .com. Bow numbers will not be issued for this event. There will be no skippers' meeting. Race Committee will make any pertinent announcements on VHF channel 71 at 0930 hrs. the first day of racing. Subsequent day briefings will be on the water on VHF 71 prior to racing



10 THE START

SI 10.4 is replaced with:

10.4. A RC boat may display an "X" flag, a "U" flag, or a black flag positioned near Mark 1 and attempt to notify boats that have been OCS or disqualified in accordance with RRS 30.3 or RRS 30.4 and will display their bow number(s) or sail number(s). Any boat notified that she has been disqualified shall leave the race course immediately.

15 PROTESTS AND REQUEST FOR REDRESS:

SI 15.1 is replaced with:

15.1. Protests and requests for redress or reopening shall be delivered Online on Yachtscoring by logging into the owner's corner and filling out the online form, or by filling out a protest form and emailing a picture (or pictures) of it to protest@coralreefyachtclub.org.

SI 15.3 is replaced with:

15.3. Notices will be posted on the YS ONB no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held by virtual zoom conference meeting. Each competitor and witness will be required to separately join the Zoom meeting using their own device (laptop, ipad, phone). Details of the zoom hearing login information will be sent to the registration email of all parties and each party will be responsible for providing the information to their witnesses. Each party will have to contact their witnesses to tell them to join the hearing at the appropriate time during the hearing. Witnesses must be excluded from the hearing except when they are asked to join the meeting to provide their testimony.
