Notice of Race

1 RULES

- 1.1 All races organized by the Buffalo Small Boat Sailing League (the BSBSL) will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS), this *Notice of Race* (NOR), and the *Sailing Instructions* (SI).
- 1.2 Prescriptions of 2017-2020 US Sailing except as any of these are modified by the NOR, and by the SI (and any amendments thereto) shall apply to all boats.
- 1.3 RRS 63.7 shall be replaced by: "If there is a conflict between a rule in the Notice of Race and a rule in the Sailing Instructions, the Sailing Instructions shall apply"
- 1.4 The Sailing Instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions that will be on the official notice board located at (https://yachtscoring.com/notice_board.cfm?eid=13045)

2 ADVERTISING

- 2.1 Competitor advertising will comply with World Sailing Regulation 20.
- 2.2 Boats may be required to display advertising chosen and supplied by the organizing authority.

3 ELIGIBILITY & ENTRY

- 3.1 All races are open to all boats. A boat is considered registered after both the online registration has been completed and the entry fee has been received by the organizing authority.
- 3.2 Eligible boats may enter by completing the online entry form at: (https://yachtscoring.com/event_registration_email.cfm?eID=13045)

4 ENTRY FEES

- 4.1 The entry fees for the BSBSL season is \$50 per boat.

5 SCHEDULE

- 5.1 NOR Attachment A (Schedule of Races) will apply. This can be located in "Event Documents" at: (https://yachtscoring.com/event_documents.cfm?eid=13045)
- 5.2 The scheduled time for the first warning signal of each race day will be 18:15.
- 5.3 As many races as practical will be held each race day.

6 SAILING INSTRUCTIONS
