### NOTICE OF RACE

### 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Boats shall observe the current US Sailing Special Equipment Requirements for Nearshore races However section 2 and 3 shall not apply to boats not designed and equipped with: pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Rule V, Alternative Penalties, will apply.

### 2 ELIGIBILITY AND ENTRIES

- 2.1 The regatta is open to PHRF and Offshore One Design Racer-Cruisers and Non-Spinnaker Boats. At the discretion of the race committee, some divisions may be divided into separate classes. Non-Spinnaker Boats will race with the *Expressly for Fun* fleet for the first weekend's racing, and with other PHRF boats on the second weekend.
- 2.2 Eligible boats may enter by registering online at Yacht Scoring: http://www.yachtscoring.com and submitted no later than 2359, Wednesday, July 8, 2020.
- 2.3 The entry fee is \$85.00, if racing both weekends. If racing only one weekend (e.g. *Expressly for Fun*), the entry fee is \$50.00. Fees include guest moorings (see NoR 7).
- 2.4 For those classes not sailing One-Design under class rules, entries shall be accompanied by a valid PHRF or IRC rating certificate. PHRF certificates from other areas may be adjusted to conform to the YRA of LIS systems.

### 3 SCHEDULE, COURSES AND RACING AREA

- 3.1 The racing area will be in the waters off Larchmont Harbor.
- 3.2 For *Expressly for Fun* fleet, the first warning will be at 1155 on Saturday, July 11 and Sunday, July 12. Racing on both days will be a pursuit race around government marks.
- 3.3 For other PHRF racing:

The first warning will be at 1255 each day.

- 4.1 Sailing instructions will be available no later than 1800 Thursday, July 9, and posted only online at: www.larchmontyc.org and <a href="http://www.yachtscoring.com">http://www.yachtscoring.com</a>.
- 4.2 Scratch sheets will be available no later than 1800 Friday, July 10, posted only online, at the sites above.

### 5 SCORING

5.1 One completed race constitutes a series.

- 5.2 A boat's series score will be the total of her race scores without exclusion.
- 5.3 For PHRF, time allowances will be computed using Time on Distance.

#### 6 PRIZES

- 6.1 Series prizes will be awarded for first, second and third places in each division. Awards will be given for the fastest elapsed time and fastest corrected time in the Execution Rocks Race.
- 6.2 Perpetual trophies will be awarded at the discretion of the race committee.
- A boat which sets a new elapsed time course record in the Execution Rocks Race will receive a case of Mt. Gay Rum. The elapsed time record is 39 minutes 51 seconds, set by Christopher Dragon on 23 July 2017.
- This regatta is a qualifying event for the YRA Youth Challenge Cup, the Gitano, Sappho, Competitors, Kings Point and Allegra Knapp Mertz awards.
- 6.5 A virtual prize ceremony will be held at 2000 Sunday, July 19, via Zoom.

#### 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 78a.
- 1.3 Rule V, Alternative Penalties, will apply.

#### 2 ELIGIBILITY

- 2.1 The regatta is open to the following one-design classes: J/105, Viper 640, Etchells, J/70, IOD, Shields, S-Class, J/88 -or any other one-design class that qualifies. To qualify as a class for this regatta, three valid entries must be received for that class prior to 1800, Wednesday, July 8.
- 2.2 If a class elects to race on a single weekend, the Class Fleet Captain shall notify the race committee no later than Wednesday. July 8. On days when that class elects not to race, boats in that class will not be given a start, nor will they be scored.

### 3 ENTRIES

- 3.1 Eligible boats may enter by completing the online entry at: http://www.yachtscoring.com. Entries must be submitted no later than 2359, Wednesday, July 8, 2020.
- 3.2 The entry fee is \$85.00 per boat. For classes electing to race only one weekend the entry fee is \$50.00. The Entry Fee includes guest moorings (see NoR 10).

### 4 SCHEDULE

- 4.1 The first warning signal will be at 1225 each day.
- 4.2 The race committee intends to run multiple races each day.
