#### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 For PHRF entries, the current PHRF Regulations as administered by the YRALIS will apply.
- 1.3 PHRF boats shall observe US Sailing Safety Equipment Requirements.
- 1.4 The sailing instructions will state that Appendix V1, Penalty at the Time of an Incident, will apply.

#### 2 ELIGIBILITY

- 2.1 All skippers shall be members of the YRALIS. New members or those who need to renew may apply by going to [www.yralis.org](http://www.yralis.org)
- 2.2 The regatta is open to both PHRF and PHRF Navigator Boats with valid certificates and the following One Design Classes: J 105, J 88.
- 2.3 PHRF Navigator class may include Spinnaker and Non-Spinnaker divisions.

#### 3 ENTRIES

- 3.1 Eligible boats may enter by submitting an online entry at <http://www.yachtscoring.com>. Discounted registration fee is \$70.00 and is due by Friday July 24<sup>th</sup>, 2020. Entries received after July 24<sup>th</sup> will be subject to a \$25.00 late fee

#### 4 SCHEDULE

- 4.1 Sat. Aug 1 1200 1<sup>st</sup> Warning signal for PHRF & Off-Shore One Design Classes
- 4.1 Sun. Aug 2 1200 1<sup>st</sup> Warning signal for PHRF & Off-Shore One Design Classes
- 4.2 The race committee intends to run multiple races each day. The number of races conducted each day is at the sole discretion of the race committee. The PHRF Navigator Classes will have 1 distance race each day.
- 4.3 There will be no on shore events for this regatta. Winners will be announced on the YRALIS website along with the winners of the IHYC and AYC circles. Trophies will be mailed.

#### 5 SAILING INSTRUCTIONS

#### 6 VENUE

The starting area will be approximately 1nm west of Bell 32A

#### 7 THE COURSES

- 7.1 PHRF and all One Design courses will be Windward/Leeward as described in the sailing instructions.
- 7.2 PHRF Navigator Class will be using Marks as described in the sailing instructions.
- 7.3 For PHRF Windward/Leeward YRALIS 2020 Windward/Leeward ratings will be used.
- 7.4 For PHRF Navigator YRALIS 2020 Distance ratings will be used.

#### 8 SCORING

- 8.1 One completed race constitutes a series.
- 8.2 PHRF time allowances will be computed using time on distance.
- 8.3 If fewer than five races are completed, a boat's series score will be the total of her race scores. If five or more races are completed a boat's series score will be the total of her race scores excluding her worst score.
- 8.4 Scoring for PHRF YRA Season Trophies will be double weighted for this event.

## 9 PRIZES

- 9.1 Prizes will be awarded for First and Second place for classes with seven or less entries. Prizes for First through Third will be awarded to classes with entries with eight or more. All prizes will be mailed to the winners.
- 9.2 YRA Championship prizes will be awarded to the Best Performance of a yacht on each circle as determined by the OA.
- 9.3 This regatta is a qualifying event for the YRA Youth Challenge Cup, the Gitano, Sappho, Competitors, Kings Point and Allegra Knapp Mertz awards.

## 10 COVID-19 PROTOCOLS

- 10.1 Skippers and crews shall comply with the Club's current Covid-19 Protocols below. A breach of this rule shall not be grounds for protest by a boat. This changes RRS 60.1(a).
- 10.2 Please be advised that due to the current COVID-19 situation, there are increased protocols in place and limited amenities available at RYC. Please review the following guidelines. Your reply and confirmation of adherence to these is required before further arrangements can be made.
- Face coverings are required at all times on the launch
  - Face coverings are required, and gloves are recommended, on the fuel dock
  - Access is not available to the clubhouse or clubhouse decks
    - There may be a possibility for take out orders to be placed with the main clubhouse; please inquire with the clubhouse on arrival for availability
  - Access is not available to the beach, pool, or snack bar
  - Parking is not available on club property for vehicles of transient boats
  - Restrooms are accessible in the bathhouse, however, due to state guidelines, the showers are not available
  - Social distancing should be practiced while on club property

This changes rule T4 and 63.3(a).
