## **General Information**

**(This general information does not rank as rules, if needed as a rule, it is explicitly included in the NOR, itself or SIs)**

- Because of COVID-19 regulations, there is a cap of 96 racers, persons, in a race. Each soul on board a racing sailboat counts toward the 96. This will be handled on a first come basis (Is a rule in the NOR)
- There are no combined, series or overall winners, awards or trophies
- Racers must comply with PCYC COVID-19 ... (is a rule in the NOR)
- As the situation is extremely fluid, including last minute cancellation of COVID-19 issues, please check the online Notice Board right up to the start
- There is no charge/fee for any participant who has donated any part of their registration fee previously paid in 2020 for the LO300/600, Susan Hood Trophy Race (SHTR) or LOSHRS. The donation ranks as completing the payment component of a complete registration.

**As sailboat racing is a team sport and as such the requirement for physical/social distancing of two meters of individuals and other sailboats can be waived for short periods of time. Consistent and persistent close contact within two meters needs to be avoided.**

**The number of crew, including skipper/person in charge, is limited to the number that can distance themselves from each other by two meters.**

*The notation '[DP]' in a rule in the Notice of Race (NOR), Sailing Instructions (SIs) or other additional document that is a rule means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification.*

*The notation '[NP]' in a rule in the Notice of Race (NOR), Sailing Instructions (SIs) or other additional document that is a rule means that the penalty for a breach of that rule will not be grounds for a protest by a sailboat.*

## **1 RULES**

1.1 The race will be governed by the rules, as defined in The Racing Rules of Sailing (RRS).

1.2 Sail Canada is the Member National Authority (MNA) for the purposes of this series, including appeals.

1.3 The prescriptions of Sail Canada apply

1.4 [DP] [NP] Offshore Special Regulations (OSR)

1.4.1 All LOSHRS races are a Category 4 Event under the World Sailing Offshore Special Regulations. The Special Regulations for Category 4 apply with prescriptions from Sail Canada and as amended by the Lake Ontario Offshore Racing apply, as documented in:

*Lake Ontario Offshore Special Regulations for Category 4 Monohulls*

*Lake Ontario Offshore Special Regulations for Category 4 Multihulls*

These are available at the Registration and Race Document Web Site.

1.5 The event is governed by the following:

1.5.1 [DP] [NP] *LOOR Sailboat and Person in Charge (PIC)/Skipper Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement, and Acceptance of Ontario Sailing's Concussion Protocol, and Agreement to act as the Designated Person for LOOR Events 2020 ("LOOR Sailboat and PIC Release")*. {To be electronically signed by the Person in Charge (PIC)/Skipper during the registration processed}

1.5.2 [DP] [NP] *LOOR Crew Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement and Acceptance of Ontario Sailing's Concussion Protocol – Athletes and Participants for LOOR Events 2020 ("LOOR Crew Release")*. {To be electronically signed by all crew during mandatory crew registration in the Crew's Corner on the Registration and Web site.}

1.6 [DP] [NP] The event is governed by *PCYC's COVID-19 Waiver & Code of*

*Conduct*, available under the link "Event Documents" on the Registration and Race Document Web Site. See Figure 1 Where to find on the Registration and Race Document Web Site on page 14

1.7 Applicable Class Rules

**Single-handed & Double-Handed racing in**

PHRF PHRF- LO Rules shall apply and PHRF-LO is the Handicap/Measurement Authority.

Multihull GLMRA Rules shall apply and GLMRA is the Handicap/ Measurement Authority.

1.8 The Racing Rule(s) will be changed as outlined below. The changes will appear in full in the Sailing Instructions. The Sailing Instructions may also change other racing rules

1.8.1 RRS 28.1

Is modified by replacing first sentence with

A boat shall *start* or be assessed the time penalty in 1.8.2, sail the course described in the sailing instructions and *finish*.

1.8.2 RRS 29.1, RRS 64.1 (a) and RRS Appendix A5

Are modified such that a sailboat that is OCS at the start of her class is assessed a 45-minute penalty. A sailboat starting six minutes or more before her Start Signal may be protested by the Race Committee, and the Protest Committee will apply an appropriate penalty if the sailboat is found to have infringed this.

1.8.3 RRS 41 Outside Help

“Outside Help” is modified herein to allow all forms of communication. Each sailboat may communicate with any person, competitor, sailboat, or outside source for information available using any means available throughout the race.

1.8.4 RRS 42.3 Exceptions

Is modified so an engine may be used for generating electrical power provided that such use does not advance the boat’s position.

1.8.5 RRS 51 Movable Ballast

Is modified to allow canting keels and water ballast, assuming the applicable class/measurement/handicap rules permit them.

1.8.6 RRS 52 Manual Power

Is modified to allow canting keels and water ballast, assuming the applicable class/measurement/handicap rules permit them.

All movable ballast systems must be capable of manual operation if the powered systems are inoperable.

Is modified to allow the use of power auto helm devices.

1.8.7 RRS 60.1 (a)

Breaches of specific Sailing Instructions, as denoted in the Sailing Instructions by “[NP]”, will not be grounds for a protest by a sailboat.

1.8.8 [NP] RRS 62.1

Is modified to allow the Race Committee the ability to announce sailboats subject to RRS 29.1.

Is modified to allow the Race Committee the ability to announce a sailboat’s successful completion at the finish.

1.8.9 RRS 64.1

Is modified that for infringements of the rules other than Part 2, the Jury may award a lesser penalty than DSQ, unless stated otherwise in the Notice of Race or Sailing Instructions.

1.8.10 [DP] [NP] RRS A4 & A5

Is modified such that a sailboat not starting within 90 minutes of her starting signal will be scored DNF.

1.8.11 World Sailing RRS Appendix WP is in effect

1.9 [DP] All sailboats shall comply with Ontario Environmental Protection Act Regulations #343 as documented at:

1.10 DP] The Person in Charge (PIC) and alternative PIC shall act as the Designated Person as defined in Ontario Bill 193, Rowan’s Law (Concussion Safety), 2018 and associated Regulations

1.11 [DP] Backstay Fleet/Division Pennant

Sailboats shall fly the listed numerical pennant, for their Fleet/Division, for which they are racing, from their backstay or other prominent position if she has no backstay.

This will be an International Code Signal numeral pennant, from one (1) to nine (9), as defined in *Fleet/Division Organization (Splits) and Starting Sequences Document*, see section 5.2

## 2 [DP] [NP] ADVERTISING

Sailboats may be required to display advertising chosen and supplied by the Organizing Authority.

Additionally, sailboats may carry advertising as permitted by Racing Rules of Sailing with no additional fee. The Organizing Authorities may reject any advertising that may conflict with any required advertising or with the interests of the Organizing Authorities or sponsors.

### **3 ELIGIBILITY AND ENTRY**

- 3.1 The total number of crew on all sailboats is limited to 96 persons for each race. This is on a first come basis for a complete registration. All souls on board count as crew.
- 3.2 Eligible sailboats may be entered in the race by registering online at the Registration and Race Document Web Site.
- 3.3 [DP] [NP] Supporting documentation for a complete entry includes all information requested in the online entry, at the Registration and Race Document Web Site, as well as the following:
1. Payment of the entry fee(s) online by the date in 5.1.
  2. The *LOOR Sailboat and Person in Charge (PIC)/Skipper Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement, and Acceptance of Ontario Sailing's Concussion Protocol, and Agreement to act as the Designated Person for LOOR Events 2020* ("LOOR Sailboat and PIC Release") electronically signed by PIC/Skipper as **part the online registration on the Registration and Race Document Web Site.**
  3. Sailboat's valid rating certificate number as soon as available for the year and before the date in 5.1 by uploading it to the Registration and Race Document Web Site.
  4. Crew information filed and maintained electronically at the Registration and Race Document Web Site, i.e., *Crew List*. This includes identification of the Person in Charge as per RRS 46 and compliance with the Sail Canada's prescription to RRS 46. The crew information shall accurately represent the crew onboard for the race. The Person in Charge shall update as necessary up to the start of the race. The Person in Charge and/or skipper are crew and must add/update their information in the *Crew List*. This includes all crew agreeing to *LOOR Crew Release of Liability, Waiver of Claims, Assumption of Risks and Indemnity Agreement and Acceptance of Ontario Sailing's Concussion Protocol – Athletes and Participants for LOOR Events 2020* as part of the mandatory crew registration in the Crew's Corner on the Registration and Web site.
- 3.4 The race is open to monohull and multihull sailboats that meet the eligibility and entrance requirements for the given race and are 20 feet LOA or

greater.

Monohull sailboat Fleets will be:

- Flying Sails (FS) and No Flying Sails (NFS) – Double-Handed (DH)
- Flying Sails (FS) and No Flying Sails (NFS) – Single-Handed (SH)

Multihull Fleets will be:

- Flying Sails (FS) – Double-Handed (DH) only

Fleets may be sub-divided into divisions based on handicap system and rating or One Design Classes. The Organizing Authority may assign sailboats to divisions and fleets based on the number of sailboats registered.

If sufficient sailboats in a one design class register, a Fleet may be created for them.

For Double-Handed (DH) and Single-Handed (SH), all souls onboard are crew.

### 3.5 Required Handicap Certificates

Single-Handed & Double-Handed sailboats racing in:

For sailboats racing under PHRF from outside the PHRF-LO area, arrangements shall be made in advance to obtain a PHRF-LO certificate. Contact PHRF-LO, [www.phrf-lo.org](http://www.phrf-lo.org) .

### 3.6 The Person in Charge shall be 18 years of age or older.

### 3.7 [DP] [NP] Competitors' sailboats shall only display a sail number registered specific to the sailboat at the time of its commission. Requests, on the *LOOR Combined Form*, available on the Registration and Race Document Web Site, to display alternative sail numbers to the sailboat's commissioned sail number may be approved by the Organizing Authority and must be filed with the registrar prior to the Participants' Meeting.

### 3.8 [DP] [NP] Crew overboard procedures shall be practised aboard the yacht at least once annually.

## 4 FEES

### 4.1 For a registration to be complete, payment is required, and all other entry must be met or fulfilled 48 hours before the race.

### 4.2 There is no charge/fee for any participant who has donated any part of their registration fee previously paid in 2020 for the LO300/600, Susan Hood



Trophy Race (SHTR) or LOSHRS. The donation ranks as completing the payment component of a complete registration.

4.3 If the new fee has been paid and the entrant is denied participant because the limit has been reached, there will be a full refund,

4.4 Required fees are as follows and payable online:

4.4.1 Single Race (Each day of Last) weekend is a single race.

The fee is doubled for racing on both days.

HST will be charged when applicable.

4.5 Payment in full for each day of racing.

4.6 LOOR will provide refunds as follows:

4.6.1 Refund Policy

If the race has to be cancelled because of COVID-19 restrictions, LOOR will refund 75%, \$33, and retain \$11, per race to cover the costs such as credit card fees, online service fees, etc. Otherwise no refunds.

## 5 SCHEDULE

5.1 Registration online, at the Registration and Race Document Web Site must be done 48 hours prior to the race.

5.2 Fleet/Division Organization (Splits) and starting sequences will be posted before September 17, 2020 on the Official Notice Board. Preliminary versions may be posted before, at the Registration and Race Document Web Site

5.3 The Participants' Meeting and Race First Warning date and time

(\*) Participant Meetings will be held online using Zoom at the scheduled time. The URL will be emailed to participants the morning of the meeting.

5.4 Time Limit: If a sailboat does not finish by 20:00 EDT on the day of the race, she shall be scored DNF.

## 6 SAILING INSTRUCTIONS

The Sailing Instructions will be available at the Registration and Race

Document Web Site by September 16, 2020. Sailing Instructions will only be available on the Registration and Race Document Web Site.

## 7 **VENUE AND THE COURSE**

If more than one course for a race, the course to be sailed will be signed before the first warning.

## 8 **PENALTY SYSTEM**

The Scoring Penalty, RRS 44.3, will apply.

## 9 **SCORING**

### 9.1 Fleets/Divisions and Handicap Systems Used

Sailboats are racing under following handicap systems.

Sailboats will be scored in their own Fleets and Divisions.

The Organizing Authority reserves the right to adjust the scratch sailboat when converting the PHRF-LO Time on Distance to Time on Time based on the registrations received by the deadline. The Time on Time ratings will be published along with the division splits.

## 10 **RADIO COMMUNICATION**

Each yacht may communicate with any person, competitor, yacht, or outside source of information available using any means available throughout the race.

## 11 **BERTHING**

[DP] [NP] There may be limited docking or mooring at PCYC and other nearby yacht clubs and marinas. Please contact them directly on availability of space and each facilities conditions and restrictions related to COVID-19.

There are number of anchorages in the vicinity of PCYC.

## 12 PRIZES

### 12.1 Individual Races

Flags are awarded for first, second and third in each Fleet/Division

If there are 10 or more starters in a Division for a given race, the Division may be sub divided into subdivisions for awarding 1, 2 and 3 place flags to the subdivisions in that race.

## 13 DISCLAIMER OF LIABILITY

Sailing is an activity that has an inherent risk of damage, injury and **disease**. Competitors in this event are participating entirely at their own risk; see **RRS 4, Decision to Race**. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including death, sustained because of participation in this event. By participating in this event, each competitor agrees to release the race organizers from all liability associated with such competitor's participation in this event to the fullest extent permitted by law.

## 14 INSURANCE

[DP] [NP] Each participating boat shall be insured with a valid third-party liability insurance policy with a minimum coverage of \$2,000,000 CAD per event for Canadian sailboats and an adequate level of third-party liability insurance applicable in Canadian and US waters for non-Canadian sailboats.

## 15 PHOTOGRAPH & VIDEO RIGHTS

[DP] [NP] All pictures, audio and video recordings, graphic logos and service names contained herein or produced during the race by or on behalf of the Organizing Authorities or Port Credit Yacht Club, are the property of either the Organizing Authorities or Port Credit Yacht Club or their respective members. No rights are granted to use pictures, graphic logos, and service names without permission.

Registrants, competitors, and participants grant the Organizing Authorities or Port Credit Yacht Club (PCYC) the unrestricted right and permission to use the name and/or image for any text, photograph, or video footage of either themselves or the sailboat they are sailing during the event to be published or broadcast in any media whatsoever (including but not limited to press, TV, social media or internet), for either editorial or advertising

purposes or to be used in press information.

Please ensure eligibility under the Racing Rules of Sailing (RRS), as stated from the RRS below:

#### “46 PERSON IN CHARGE

A boat shall have on board a person in charge designated by the member or organization that entered the boat. See rule 75.

SAIL CANADA prescribes that the designated person in charge, if resident in Canada, shall be a member of a club affiliated with SAIL CANADA.

#### 75 ENTERING A RACE

75.1 To enter a race, a boat shall comply with the requirements of the organizing authority of the race. She shall be entered by

- (a) a member of a club or other organization affiliated to a World Sailing member national authority,
- (b) such a club or organization, or
- (c) a member of a World Sailing member national authority.

75.2 Competitors shall comply with World Sailing Regulation 19, Eligibility Code.”

For a Person in Charge, who is an Ontario resident but is not a member of a Sail Canada yacht club, they can contact Ontario Sailing, [www.ontariosailing.ca](http://www.ontariosailing.ca), to purchase a ‘Maple Leaf Fund Right to Race Card’.
