NOTICE OF RACE (NoR) inc. Amendment No.1

The notation '[DP]' in a rule in this Notice of Race (NoR) means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification. The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

1 RULES

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 J/105 Class Rules are modified by Article IX of the local J-105 Fleet-3 Article/Rules. This event is designated a Level 1A event. J/105 Fleet-3 Articles/Rules can be found at <https://www.j105fleet3.org/rules>

2 SAILING INSTRUCTIONS

- 2.1 The sailing instructions will be posted on the official notice board approximately 10 days before the first scheduled day of racing.

3 COMMUNICATION

- 3.1 The online official notice board is located at <https://yachtscoring.com/emenu.cfm?eid=14298>.
- 3.2 [DP] All boats shall carry a VHF radio capable of communicating on channels 9, 13, 16, 68, 69, 70, 71, and 72.
- 3.3 On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The specific channel will be stated in the SIs.

4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to all boats of the J/22, J/30, J/70, J/105, and Etchells classes.
- 4.2 For a class to have a start, it must have a minimum of 5 paid entries by 1200 on Friday, April 23. Entry fees for boats in classes that fail to meet the minimum will be returned.
- 4.3 Boats wishing to enter shall register online at: <https://yachtscoring.com/emenu.cfm?eid=14298>
- 4.4 To be considered a valid entry in the event, a boat shall complete all registration requirements including the waiver (see NoR 4.5) and pay all fees.
- 4.5 [NP] Every competitor (skippers and all crew) shall sign the online AYC Liability and Waiver Agreement before they participate in any race of the regatta.

5 FEES

- 5.1 Early registration and entry fee of \$55 are due by 1700 on Monday, April 12. After that, registration and entry fee of \$80 will be accepted until 1200 on Friday, April 23. Entry fees are payable in full upon registering and are non-refundable.
- 5.2 The entry fee includes, at a minimum, racing and awards.

6 SCHEDULE

- 6.1 The scheduled time of the warning signal for the first race of the regatta is 1100.
- 6.2 Three races are scheduled.
- 6.3 No warning signal will be made after 1530.

7 VENUE

7.1 The racing area will be the Chesapeake Bay off the mouth of the Severn River.

8 COURSES

8.1 The courses to be sailed will be drop mark courses.

9 SCORING

9.1 RRS Appendix A4, Low Point System, will apply as changed by the SIs.

9.2 Boats not completing all registration steps by 1200 on Friday, April 23 will not be scored.

10 DISCLAIMER OF LIABILITY

10.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue *racing* is hers alone.'

11 INSURANCE

11.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$300,000 per incident or the equivalent.

12 PRIZES

12.1 Prizes will be given in each class for 1st place with 3 or more starters (boats starting in at least one race), 2nd place with 5 or more starters, and 3rd place with 7 or more starters.

12.2 Additional prizes may be awarded at the discretion of the organizing authority.
