

Sail22 J/70 Invitational

March 25-28, 2021

NOTICE OF RACE

The organizing authority is Sail22, LLC in conjunction with Twelve USA, Inc. The regatta office and berthing site is Shake-A-Leg, South Bayshore Drive, Miami, Florida, USA. This is a J/70 invited class event.

1. RULES

1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* (RRS).

1.2 Rules and US Sailing prescriptions which are applicable are: rule 61.4, Appendix R, prescriptions to 60.3, 67, 70.5(a) 76.1, 88.2, and Appendix V. No other prescriptions apply.

1.3 Except for the rules in RRS PARTS 2 and 3, the protest committee may impose alternate penalties for breaking a rule in accordance with RRS 64.1.

1.4 If there is a conflict between languages, the English text will prevail.

1.5 If there is a conflict between the notice of race, the sailing instructions, and any other rules of the regatta, the sailing instructions will take precedence. This changes RRS 63.7.

1.6 All boats shall carry a functioning VHF radio for emergencies and monitoring the race committee.

2. ADVERTISING

2.1 Boats may be required to exclusively display the event sponsor's advertising in accordance with World Sailing (WS) Regulation 20, materials to be supplied by the organizing authority at check-in. WS Regulation 20.9.2 will apply.

3. ELIGIBILITY AND ENTRY

3.1 Boats must be eligible for entry in accordance with WS, J70 Class rules.

3.3 The deadline for early entry is February 25th, 2021. Entry is not complete unless accompanied by the complete entry fee. Late entries after February 25th, 2021 will be subject to a late fee.

3.4 All competitors, PERSON IN CHARGE and crew, are required to sign the regatta waiver & Covid-19 Waiver form online to complete a boat's entry.

6. VENUE AND COURSES

6.1 The racing area is on Biscayne Bay approximately 3 nm south of Dinner Key Channel Marker FIG2.5s5M'1'.

6.2 Courses will be windward/leeward with gates and offsets using MarkSetBot race marks.

7. SAILING INSTRUCTIONS AND AMENDMENTS

7.1 Amendments to the notice of race and sailing instructions will be posted on yachtscoring.

8. PENALTIES

8.1 As changed in this notice of race rules 1.2 and 1.3.

9. SCORING

9.1 We will attempt up to 5 races each day with a throw out per class rules at 6 races.

10. LAUNCHING/BERTHING/HAULING/TRAILER STORAGE

10.1 Launching/berthing/hauling and trailer storage will be at Shake-A-Leg Miami. There will be a limit for 40 boats at SALM.

11. RADIO COMMUNICATIONS

11.1 Except in an emergency, a boat that is racing shall not make or receive voice or data transmissions that are not available to all boats.

12. SUPPORT PERSONS AND BOATS

12.1 *Support Persons* and the operation of their vessel agree to be governed by The Racing Rules of Sailing.

13. COMPETITOR IDENTIFICATION

13.1 All competitors will need to be registered on Yachtscoring so they can be added to a list that is needed for temperature checks each morning at Shake-A-Leg Miami.

14. INSURANCE

14.1 Each participating boat shall be insured with current third-party liability insurance with a minimum coverage of not less than \$100,000/300,000. A copy of the coverage page will need to be emailed to info@bacardiinvitational.com prior to registration

15. DISCLAIMER OF LIABILITY

15.1 In addition to RRS 4, DECISION TO RACE (RRS2017-2020), or RRS 3, DECISION TO RACE (RRS2021-2024), the safety of a boat and her entire management shall be the responsibility of the owner(s), and an owner's representative. Sailing is an activity that has an inherent risk of damage and injury. Competitors in this event are participating entirely at their own risk. The race organizers (organizing authority, race committee, protest committee, host club, sponsors, or any other organization or official) will not be responsible for damage to any boat or other property or the injury to any competitor, including disease and death, sustained as a result of participation in these events. By participating in these events, each competitor agrees to release the race organizers from any and all liability associated with participation in this event to the fullest extent permitted by law.

15.2 Based on any public health consideration, competitors agree to follow Centers for Disease Control and Prevention (CDC), State of Florida and County of Miami-Dade guidelines, the OA's and Shake a Leg's Miami policies regarding coronavirus, COVID- 19, that are in effect at the time of each regatta.

15.3 Before participation at any event, every owner, competitor, coach and/or support personnel shall digitally sign a Waiver of Liability as posted on Yacht Scoring.

15.4 By participating in these events, each competitor agrees to release the regatta organizers from any and all liability associated with participation in this event to the fullest extent permitted by law.

16. MEDIA RIGHTS

16.1 Competitors give absolute right and permission for video footage and photographs of themselves or their boat to be published in any media for press, editorial, or advertising purposes.
