Cruising Class Amendments to 2021 Cedar Point Yacht Club Sailing Instructions for the Fixed Mark Race Area.

Amendment #1 –In the Wednesday Night Series, boats shall race in the following divisions and fly the appropriate code flag from their backstay:

Non-spinnaker divisions, grouped based on their current YRA of LIS Adjusted W/L Non-Spinnaker PHRF rating. For these divisions, the use of flying sails is prohibited

Division 1 Rating 122 and lower

Division 2 Rating 123 to 149

Division 3 Rating 150 and higher

Spinnaker Division 4, all PHRF ratings.

Amendment #2 –In all Cruising Class Series other than Wednesday Night, boats shall race in the following divisions and fly the appropriate code flag from their backstay:

Division 1 – Spinnaker boats with no limit on crew size

Division 2—Spinnaker boats racing single- or double-handed

Division 3 – Non-spinnaker boats, for which the use of flying sails is prohibited

Amendment #3 – Scoring: In the Wednesday Night Series, the YRA of LIS Adjusted W/L Non-Spinnaker PHRF rating shall be used to score boats in Divisions I, II and III, and the YRA of LIS Adjusted W/L Spinnaker PHRF rating shall be used to score boats in Division IV. In all other Cruising Class Series, the YRA of LIS Adjusted W/L Non-Spinnaker PHRF rating shall be used to score boats in Division III, and the YRA of LIS Adjusted W/L Spinnaker PHRF rating shall be used to score boats in Division I (Fully-Crewed) and II (Single- or Double-Handed).

Each race and series shall be scored using the Low Point System of Appendix A of The Racing Rules of Sailing, modified so that boats which did not start correctly (OCS), did not sail the course (NSC), did not finish (DNF), retired (RET), or were disqualified (DSQ) shall be scored points for the finishing place one more than the number of boats that started in that race. Time limits, and the scoring for boats that are still racing when the time limit expires (TLE), are set forth in Instruction 16 of the *Cedar Point Yacht Club Sailing Instructions for the Fixed Mark Race Area*. Boats which did not compete (DNC) or did not start (DNS) in any race shall be scored points for the finishing place one more than the number of boats in the series and shall not be included as a boat starting. Each boat's series score shall be the total of her best race scores in the number of races needed to qualify for that series, excluding its other scores. This changes RRS A2 and A5.2.

Corrected times shall be calculated for each race using Time on Time ("ToT") scoring. Time Correction Factors ("TCF") used for ToT scoring will be calculated by the formula $TCF=A/(B+PHRF \text{ rating})$ using $A=650$ and $B= 550$.

Amendment #4 – Prizes: Daily and series prizes in each division will reflect PHRF handicap results. Daily prizes for each division will be awarded to the top three boats in each day's racing. Series prizes for each division will be awarded based on their order of finish in their division series. Wednesday Night Daily and Series prizes will be awarded only to CPYC member boats.
