Lake Erie Challenge is the organizing authority Notice of Race

1 RULES

1.1 All races organized by the Lake Erie Challenge (LEC) will be governed by the rules as defined in The Racing Rules of Sailing (RRS), this Notice of Race (NOR), and the Sailing Instructions (SI).

1.2 Prescriptions of 2017-2020 US Sailing and Performance Handicap Racing Federation - Lake Erie (PHRF-LE) except as any of these are modified by the NOR, and by the SI (and any amendments thereto) shall apply to all boats.

1.3 RRS 63.7 shall be replaced by: "If there is a conflict between a rule in the Notice of Race and a rule in the Sailing Instructions, the Sailing Instructions shall apply"

2 ADVERTISING

2.1 Competitor advertising will comply with World Sailing Regulation 20.

2.2 Boats may be required to display advertising chosen and supplied by the organizing authority.

3 ELIGIBILITY & ENTRY

3.1 All races are open to all boats. A boat is considered registered after both the online registration has been completed and the entry fee has been received by the organizing authority.
