## **SAILING INSTRUCTIONS (SIs)**

[DP] The notation '[DP]' in a *rule* means that the penalty for a breach of the *rule* may, at the discretion of the protest committee, be less than disqualification.

#### 1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 The current PHRF Regulations as administered by the YRA of LIS will apply.
- 1.3 Boats shall observe the current US Sailing Special Equipment Requirements for Nearshore races. However section 2 and 3 shall not apply to boats not designed and equipped with: pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.4 Rule V, Alternative Penalties, will apply.
- 1.5 Appendix T, Arbitration, will apply as changed: At the end of T4, Arbitration Meeting Outcomes, add: (c) If a protest is not withdrawn after arbitration, the arbitrator will not be a member of the jury that hears that protest but will be permitted to observe the testimony presented and offer evidence. This changes rule 63.3(a).

#### 2 CHANGES TO THE SAILING INSTRUCTIONS

Any changes to the sailing instructions will be posted on the official notice board no later than Saturday July 10 at 1000.

#### 3 COMMUNICATION

- 3.1 Notices to competitors will be posted on the official notice board located online at <a href="https://yachtscoring.com/notice\_board\_summary.cfm?eid=14655">https://yachtscoring.com/notice\_board\_summary.cfm?eid=14655</a>
- 3.2 Each boat shall carry a VHF radio capable of communicating on VHF 73.
- 3.3 On the water, the race committee will make courtesy broadcasts to competitors on VHF radio.
- 3.4 [DP] While racing, From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 SIGNALS MADE ASHORE

- 4.1 Signals made ashore will be displayed from the flagpole located on the front lawn.
- When flag AP is displayed ashore, "1 minute" is replaced with "not less than 60 minutes" in Race Signal AP. When flag AP over E is displayed, racing is postponed for the Cruising circle only.

#### 5 SCHEDULE OF EVENTS

- For Expressly for Fun fleet, the first warning will be at **1155** on Saturday, July 10 and Sunday, July 11. Racing on both days will be a pursuit distance race around government marks.
- 5.2 For PHRF Spinnaker, the first warning signal for all classes will be at **1255** each day. Classes may not be started as listed on the scratch sheet after the first race. Multiple races are scheduled each day at the discretion of the race committee.

#### 6 CLASS FLAGS

6.1 The class flags are:

Class Flag 1 (one) – PHRF Spinnaker

Class Flag 2 (two) - Expressly for Fun Distance Race-Spinnaker and Non-Spinnaker Divisions

- Boats shall display the numeral pennant for their division approximately 6-8 feet up on the backstay or, if the boat has no backstay, the starboard shrouds.
- Before the first warning each day, each boat shall check in by sailing past the signal vessel, hailing her sail number and receiving acknowledgement from the race committee. Radio check ins will not be acknowledged.

#### 7 RACING AREA

The racing area will be in the waters East of Larchmont Harbor.

#### 8 COURSES AND MARKS

- 8.1 For PHRF Spinnaker the courses will be windward-leeward with the leeward mark to weather of the starting line.
- 8.2 The signal vessel will display a course number on the course board no later than the warning signal.

Course: Description:

- 2 Start windward mark finishing to leeward leaving the race committee boat to starboard.
- 3 Start windward mark leeward mark finishing to windward leaving the race committee boat to starboard
- 4 Start windward mark leeward mark windward mark finishing to leeward leaving the race committee boat to starboard.
- 5 Start windward mark leeward mark windward mark leeward mark finishing to windward leaving the race committee boat to starboard
- 8.3 Course lengths are at the discretion of the race committee.
- 8.4 Expressly For Fun No later than the warning signal the race committee will announce the course to be sailed. See Addendum to this document for a list of marks and chartlet. The race committee may signal a mark "A". If so, Mark A will be a drop mark

#### 9 MARKS

- 9.1 Original rounding marks will be yellow tetrahedrons.
- 9.2 New marks, as provided in SI # 11, will be orange tetrahedrons.

#### 10 THE START

- 10.1 Races will be started in accordance with RRS 26
- 10.2 The Expressly for Fun will be a Pursuit Start. The start time scheduled for each boat will be posted by 1800 Friday July 9 online at <u>Yacht Score</u> and may also be posted on the <u>Larchmont Yacht Club website</u>
- 10.3 The starting line will be between a staff displaying an orange flag on the signal vessel and a staff displaying an orange flag on the port end.
- 10.4 Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other races.
- 10.5 If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the race committee will attempt to hail her sail number via VHF Channel 73. Failure to hail her number, failure of her to hear such a hail, or the order in which boats are hailed will not be grounds for a redress for request. This changes RRS 62.1(a).
- 10.6 A boat that does not start within 5 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2.

#### 11 CHANGE THE NEXT LEG OF THE COURSE

To change the next leg of the course, the race committee will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When a subsequent new mark is replaced, it will be the replaced by an original mark.

#### 12 THE FINISH

The finish line will be between a staff displaying a blue flag on the signal vessel and the course side of a blue flagged buoy on the starboard end

#### 13 TIME LIMITS

- 13.1 **Expressly for Fun** The time limit for the first boat to start, sail the course and finish is 1700.
- Windward/Leeward course time limit for the first boat in a division to start, sail the course and finish a race if the course is 6 miles or less will be 2 ½ hours.
  - The time limit for the first boat in a division to start, sail the course and finish a race if the course is more than 6 miles will be 3 ½ hours.
- Boats failing to finish within 45 minutes after the first boat in that division to start, sailed the course and finished will be scored "TLE". This changes rule 35.
- 13.4 **Execution Rocks** The time limit for all boats to start, sail the course and finish is 1500

#### 14 HEARING REQUESTS

- 14.1 The protest time limit is 60 minutes after the RC finish vessel personnel come ashore. All protest time limits will be posted on the official notice board.
- Rule 61.1(a) is changed, add: Immediately after finishing, a protesting boat shall notify the race committee of her intent to lodge a protest and the identity of the boat she intends to protest.
- 14.3 Hearing requests such as protests and requests for redress may be filed electronically from the "File a Protest" link on the official notice board. This changes RRS 61.3 and 62.2. All such requests shall be delivered within the appropriate time limit.
- The official notice board will be on the <a href="https://yachtscoring.com/notice\_board\_summary.cfm?eid=14655">https://yachtscoring.com/notice\_board\_summary.cfm?eid=14655</a>. Notice of hearings will be posted on the official notice board as soon as possible after the protest time limit has expired.
- Notices of protests by the race committee or protest committee will be posted on the official notice board to inform boats under RRS 61.1(b).
- 14.6 Hearings will be conducted at Larchmont Yacht Club, 2<sup>nd</sup> Floor.

#### 15 SCORING

- 15.1 One completed race will constitute a series.
- 15.2 For PHRF, time allowances will be computed using Time on Time.
- 15.3 A boat's series score will be the total of her race scores without exclusion.
- Boats scored "TLE" will receive 2 points more than the number of finishers in that race but will not be scored worse than DNF.

#### 16 SAFETY REGULATIONS

- Prior to the warning signal of her first race each day, a boat shall sail past the stern of the race signal vessel, hail her sail number and be acknowledged by the race committee.
- 16.2 [DP] A boat that retires from a race or does not intend to compete in a race after checking in shall notify the race committee as soon as possible.

#### 17 PRIZES

Series prizes will be awarded for classes that qualify in NOR 4.1. Prizes will be awarded to first, second and third place boats following the completion of racing on the front lawn Sunday July 18, 2021

#### 18 RISK STATEMENT

Competitors are reminded of the Disclaimer of Liability to which they agreed as stated in the notice of race.


#### 19 COVID-19 PROTOCOLS

Skippers and crews shall comply with the Club's current Covid-19 protocols, as posted on the Club's website. A breach of this rule shall not be grounds for protest by a boat. This changes RRS 60.1(a)

[NP] The notation '[NP]' in a *rule* means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a). [DP] The notation '[DP]' in a *rule* means that the penalty for a breach of the *rule* may, at the discretion of the protest committee, be less than disqualification.

#### 1 RULES

- 1.1 The event is governed by the rules as defined in *The Racing Rules of Sailing*.
- 1.2 Rule V1, Alternative Penalties, will apply.

#### 2 CHANGES TO THE SAILING INSTRUCTIONS

Any changes to the sailing instructions will be posted no later 1800 on the day before they take effect on the YRA website and on the YRA Mid Sound Google Group page Oral changes may be made on the water via VHF radio and acknowledged by each participate.

#### 3 COMMUNICATION

- 3.1 Notices to competitors will be posted to the google group page <a href="https://groups.google.com/g/yra-mid-sound-one-design">https://groups.google.com/g/yra-mid-sound-one-design</a> and may be posted on the notice board of the host club.
- 3.1 Each boat shall carry a VHF radio capable of communicating on VHF 78A
- 3.2 On the water, the race committee will make courtesy broadcasts to competitors on VHF radio.
- 3.3 [DP] While racing, From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 SIGNALS MADE ASHORE

- 4.1 Signals made ashore will be displayed from the host club flagpole and posted to the google group page.
- 4.2 When flag AP is displayed ashore, "1 minute" is replaced with "not less than 1 hour" in Race Signal AP.

#### 6 CLASS FLAGS

Class flags will be numeral pennants. Class insignias may be substituted.



#### 7 RACING AREA

The starting area will be in the vicinity mid-way between Larchmont and American Yacht Clubs

#### 8 COURSES

- 8.1 Courses will be windward-leeward or triangle, windward leeward.
- 8.2 The signal vessel will display the course number, approximate compass bearing and the distance on the course board

<sup>\*\*</sup> Special Amendment to the Sailing Instructions for the Distance Race will be issued.

no later than the warning signal.

8.3 The race committee may elect to give some classes a substantially shorter windward leg than is posted for the other classes. If it does so, it will announce its intentions on VHF channel 78A and will post the number "0" on the signal board next to that Class signifying a shorter windward leg for those classes.

**SAMPLE COURSE BOARD** (showing a course of 210 degrees, 1.0 nm to the windward mark and course 40 for Div 1-4 and course -4 for Div 5-6 the race:

Bearing	Range	Division	Course
210	1.	1-4	4 0
	0	5-6	- 4

If the course is the same for the succeeding class or classes, their course will be left blank.

- 8.4 Course will be designated as follows:
  - 2 windward, (offset), finish to leeward
  - 3 windward, (offset), leeward mark **or gate**, finish to windward
  - 4 windward, (offset), leeward mark **or gate**, windward, finish to leeward
  - 5 windward, (offset), leeward mark **or gate**, windward, leeward mark **or gate**, finish to windward 6 -triangle, windward, finish to leeward.

The course number followed by 0 indicates a windward offset mark. ie 40 signals course 4 with an offset mark.

All marks shall be left to port, except if a leeward gate is set.

8.5 Course lengths are at the discretion of the race committee.

#### 9 MARKS

- 9.1 Original rounding marks will be orange tetrahedrons
- 9.2 New marks, as provided in SI # 12, will be yellow tetrahedrons
- 9.3 If the race committee elects to give one or more classes a shorter windward leg, it will signal it with a "-" (minus) before the course number. The windward mark will be a white inflatable for those classes. This will not be a mark of the course for the other classes. A new mark, as per instruction 10, Changing the next leg of the course, will be a white mark with a black band.
- 9.4 The offset mark, if used, will be a round orange inflatable

#### 10 THE START

- 10.1 The starting line will be between a staff displaying an orange flag on the signal vessel and a staff displaying an orange flag on the port end.
- 10.2 Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other races.
- 10.3 If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the race committee will attempt to hail her sail number via the official vhf channel. Failure to hail her number, failure of her to hear such a hail, or the order in which boats are hailed will not be grounds for a redress for request. This changes RRS 62.1(a).
- 10.4 A boat that does not start within 10 minutes after her starting signal will be scored Did Not Start without a hearing. This changes RRS A5.1 and A5.2.
- 10.5 Any re-commencement of the starting sequence will be preceded by repetitive sounds and an announcement on Ch 78A approx. 1 minute prior to the warning signal. Boats are reminded to stay within range of the starting area
- 10.6 If there is only one boat in a class, that boat will be recorded for its participation, but not given an individual start. However, the race committee may allow that boat to start with another class, if approved by that class and the race committee. If so, an announcement will be made prior to the attention signal. If two or more classes have fewer than three boats participating on a day, the race committee may, with the approval of the classes, combine their starts but may not for the first race of the day. If so, an announcement will be made prior to the attention signal. Classes will be scored separately.

#### 11 CHANGE THE NEXT LEG OF THE COURSE

To change the next leg of the course, the race committee will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When a subsequent new mark is replaced, it will be the replaced by an original mark.

#### 12 THE FINISH

12.1 The finish line will be between a staff displaying a blue flag on the signal vessel and the course side of a blue flagged buoy on the opposite end.

- 12.2 For a windward finish the finish line will be between the windward mark and yellow flag on the race committee vessel to starboard.
- 12.3 The race committee may assign a finish position to any unfinished boats, provided that the appropriate finish place for those boats can be determined in a reasonable manner.
- 12.4 Flag A displayed with no sound while boats are finishing means "No more racing today".

#### 13 TIME LIMITS

- 13.1 The time limit for the first boat in each division to start, sail the course and finish is 2 ½ hours.
- Boats failing to finish within 30 minutes after the first boat in that division has started, sailed the course and finished will be scored "TLE". This changes rule 35.

#### 14 HEARING REQUESTS

- 14.1 For all races days, other than special events, written protests and requests for redress shall be emailed to the YRA office at office@yralis.org, no later than the 1st business day following the race. These hearings will be heard on the following Thurs at a time and place that all parties agree
- Rule 61.1(a) is changed, add: Immediately after finishing, a protesting boat shall notify the race committee of her intent to lodge a protest and the identity of the boat she intends to protest.

#### 15 SCORING

- 15.1 For daily scores, the low point scoring system of Appendix A will apply with multiple races scheduled A boats daily score will be the total of her race scores without exclusion.
- Boats scored "TLE" will receive 2 points more than the number of finishers in that race but will not be scored worse than DNF.
- 15.4 For season scoring, fleets may use the Cox-Sprague scoring system as shown in the One Design Championship Rules section of the YRA Year Book; however, each fleet may choose any scoring system.
- 15.5 All scores shall be submitted to the YRA Office following the completion of racing. Scores can be emailed to scores@yralis.org and cparthemos@gmail.com

#### 16 SAFETY REGULATIONS

- Prior to the warning signal of her first race each day, a boat shall sail past the stern of the race signal vessel, hail her sail number and be acknowledged by the race committee.
- 16.2 [DP] A boat that retires from a race or does not intend to compete in a race after checking in shall notify the race committee as soon as possible.
- 16.3 [DP] All boats and support vessels shall comply with RRS 37 when flag V (white rectangle with red X) is displayed with 1 sound.
- All boats are reminded of the Preamble to Part 2 When Boats Meet regarding boats sailing under these rules and a vessel that is not, she shall comply with the International Regulations for Preventing Collisions at Sea (IRPCAS).

#### 17 SUPPORT BOATS

- 17.1 Instructors, coaches, spectators and other support boats shall stay outside areas where boats are racing from the time of warning signal for the first class to start until all boats have finished or retired or the race committee signals postponement or abandonment. Coaching is not permitted after a general recall. All support boats shall stay at least 100 yards away from any racing boat and from the starting and finishing area and shall move slowly and with minimal wake
- 17.2 Coaches and support personnel are required to monitor the race committee VHF channel and follow any safety instructions issued by the race committee. The VHF channel will be 78a

#### 18 TRASH DISPOSAL

Trash may be placed aboard official or support person vessels.

#### 19 PRIZES

- 19.1 YRA of LIS Season prizes will be awarded on Dec 5th at the YRALIS Annual Meeting to each qualifying helmsman placing first in a recognized YRA Fleet as per the YRA One Design Championship Rules.
- 19.2 This series is a qualifier for the Cow Bay Perpetual Trophy and the Russell J. Nall Memorial Trophy Prizes and other series prizes as defined in the YRA of LIS Racing Program.

#### 23 RISK STATEMENT






#### **COURSE DIAGRAMS** – the leeward mark may or may not be a gate (Schematic – not to scale)



#### 2 CHANGES TO THE SAILING INSTRUCTIONS

- 2.1 Any changes to the sailing instructions will be posted before 1130 on the day they take effect, except that any change to the schedule will be posted by 1800 on the day before it takes effect.
- 2.2 Oral changes may be made on the water via VHF radio and acknowledged by each boat.

#### 3 COMMUNICATION

- 3.1 Notices to competitors will be posted on the official notice board located on the veranda of the main clubhouse.
- 3.2 Each boat shall carry a VHF radio capable of communicating on VHF channel 05A.
- 3.3 On the water, the race committee may make courtesy broadcasts to competitors on VHF radio.
- 3.4 [DP]While racing, from the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 SIGNALS MADE ASHORE

#### 7 RACING AREA

The racing area will be in the waters off Larchmont Harbor.

#### 8 COURSES AND MARKS

- 8.1 Courses will be windward-leeward with either 2 or 4 legs
- 8.2 The signal vessel will announce the course number, whether or not there is a gate and the color of marks before the warning signal of each race via the vhf radio.

Course: Description:

- 2 Start windward mark leaving the mark to port, finish.
- Start windward mark, leaving the mark to port leeward mark or gate windward mark finish. If there is a mark instead of a gate, leave the mark to port.
- 8.3 Course lengths are at the discretion of the race committee.

#### 9 MARKS

- 9.1 Original rounding marks will be orange hippity hops.
- 9.2 New marks, as provided in SI # 11, will be announced from the signal vessel.

#### 10 THE START

- 10.1 Races will be started in accordance with Appendix U Audible Signal Racing System.
- The start and finish line will be between a staff displaying an orange flag on the signal vessel and a staff displaying an orange flag on the opposite end. This changes Blue flag in Race Signals.
- 10.4 If any part of a boat's hull is on the course side of the starting line at her starting signal and she is identified, the race committee will attempt to hail her sail number via the official VHF channel. Failure to hail her number, failure of her to hear such a hail, or the order in which boats are hailed will not be grounds for request for redress. This changes RRS 62.1(a).
- 10.5 A boat that does not start within 4 minutes after her starting signal will be scored DNS without a hearing. This changes RRS A5.1 and A5.2.

#### 11 CHANGE THE NEXT LEG OF THE COURSE

To change the next leg of the course, the race committee will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When a subsequent new mark is replaced, it will be the replaced by an original mark.

#### 12 TIME LIMITS

- 12.1 The time limit for the first boat in each division to start, sail the course and finish is 60 minutes.
- Boats failing to finish within 15 minutes after the first boat in that division has started, sailed the course and finished will be scored "TLE". This changes rule 35.

#### 13 HEARING REQUESTS

Three Minute Justice will apply as described in Addendum A.

#### 14 SCORING

- 14.1 One completed race in any of the three events will constitute a regatta for that event.
- In order to qualify for the Ideal 18 Summer Regatta Series, a skipper must compete in Larchmont Race Week and at least one of the other events (either the June or August event). A skipper who competes in all three events will discard either June or August, whichever is worse.
- 14.3 Scoring for June 19 and Aug 14 will be high-point without exclusion. Scoring for Race Week will be low point without exclusion.
- 14.4 Scoring for the series will include the results from the Larchmont Race Week, converted to high point, plus the results for the skipper's best of the one-day regattas. The series score for each boat will be a percentage calculated as follows: divide the sum of her race scores by the sum of the points

she would have scored if she had placed first in every race in which she competed; multiply the result by 100. The qualifying boat with the highest series score is the winner, and others are ranked accordingly.

14.5 Boats scored "TLE" will receive 2 points more than the number of finishers in that race but will not be scored worse than DNF.

#### 15 SAFETY REGULATIONS

- Prior to the warning signal of her first race each day, a boat shall sail past the stern of the race signal vessel, hail her sail number and be acknowledged by the race committee.
- 15.2 [DP] A boat that retires from a race or does not intend to compete in a race after checking in shall notify the race committee as soon as possible.
- 15.3 [DP] All boats and support vessels shall comply with RRS 37 when flag V (white rectangle with red X) is displayed with 1 sound.

#### 16 PRIZES

- 16.1 Prizes for the series will be awarded to the top three finishers after racing on August 14.
- 16.2 Prizes for Larchmont Race Week will be awarded on the front lawn following racing on July 11.

#### 17 COVID-19 PROTOCOLS

Skippers and crews shall comply with the Club's current Covid-19 protocols, as posted on the Club's website. A breach of this rule shall not be grounds for protest by a boat. This changes RRS 60.1(a)

#### 18 RISK STATEMENT

# Addendum A to Sailing Instructions Three-Minute Justice

A boat may protest under any racing rule, class rule, etc. and request redress by notifying the race committee after finishing, but Three-Minute Justice will apply only to a boat protesting under the rules of Part 2 and rule 31. All other hearings, including race committee, protest committee, and technical committee protests; protests involving rule 44.1(b); misconduct issues; and redress requests will be handled by the protest committee ashore.

#### For Three-Minute Justice:

- 1. Flag and hail as per rule 61.1. No written protest form required.
- 2. Hearing held immediately after finishing that race, if possible.
- 3. Each party selects one rules-savvy competitor to hear the protest, but (a) if event is a team event, the competitor may not be from the same team, and (b) a party cannot select the same competitor more than once per regatta.
- 4. No witnesses allowed.
- 5. At the outset of the hearing, establish validity. If valid, proceed with hearing. If not valid, close hearing.
- 6. The parties have one minute each to present their case and ask questions of the other party
- 7. The judges have one minute to deliberate in private and decide the case, and are strongly encouraged to come to a decision.
- 8. If the two judges cannot agree, the protest is disallowed.
- 9. A boat found at fault will be disqualified.
- 10. All decisions are final and cannot be appealed.
- 11. The judges report their decision to the race committee or another designated official.
- 12. To repeat, if the judges find that an issue other than the rules of Part 2 or rule 31 is involved in the hearing, they must immediately close the hearing and notify the race committee.




