### **SAILING INSTRUCTIONS** **2022 Mudhead MooringBall Run** **Mystic River Mudhead Sailing Association** **May 1, 2022 - October 31, 2022**

#### **1. Rules**

1.1. The regatta will be governed by the rules as defined in the Racing Rules of Sailing.

#### **2. Notice to Competitors and Changes to the Sailing Instructions**

2.1. Notices to competitors will be posted on the event page online at [www.mudhead.org/Racing](http://www.mudhead.org/Racing).

2.2. Changes to the Sailing Instruction will be posted on the event page before 1800 on the day before the event window opens.

#### **3. Check In and Check Out**

3.1. Competitors shall check in with the MRMSA race committee via E-mail at [GregPRORC@GMail.com](mailto:GregPRORC@GMail.com) within two hours prior to beginning the event. Competitors shall check out with the MRMSA race committee via E-mail at [GregPRORC@GMail.com](mailto:GregPRORC@GMail.com) within two (2) hours of leaving the race course.

#### **4. Courses**

4.1. The course is a circumnavigation of Fisher's Island in a direction and at a time of the competitor's choosing. Competitors shall pass seaward, relative to Fisher's Island, of following government navigational aids:

- North Hill Bell R-2
- Race Point Nun N-2
- Lords Passage MOA(L)
- Wicopesset Rock Cans C-7, C-9 and C-11
- Seal Rocks Can C-15
- Youngs Rock Can C-17
- Chocomount Can C-1W
- Clay Point Can C-5

#### **5. Start/Finish**

5.1. Start: Competitors shall select a government navigational aid as their starting mark and shall record the local GPS time from a position abeam of and within two (2) boat

lengths of this navigational aid. The starting mark shall be one of the navigational aids described in Paragraph 4, Courses, above.

- 5.2. Finish: A competitor will be considered finished when she has completed the race course, as described in Paragraph 4, Courses, above; and attained a position abeam of and within two (2) boat lengths of the selected starting mark.

## **6. Time Limit**

- 6.1. The time limit for each competitor will be six (6) hours from the competitor's starting time.

## **7. Protest**

- 7.1. Competitors wishing to file a protest shall inform the MRMSA race committee when checking out from the race course.
- 7.2. Protests forms are available online at Yacht Scoring under Documents/For Competitors.
- 7.3. Completed protest forms shall be filed to the MRMSA race committee via E-mail at [mudhead@mudhead.org](mailto:mudhead@mudhead.org) within six (6) hours of completing the race course.
- 7.4. Protests will be heard at a mutually agreeable time and location.

## **8. Log**

- 8.1. Competitors shall complete the attached race log and submit it to the MRMSA race committee via E-mail at [GregPRORC@GMail.com](mailto:GregPRORC@GMail.com) prior to 1800 on November 15<sup>th</sup>, 2022.
