## Notice of Race

V4 18<sup>th</sup> May 2022, major changes in **blue**

The notation '[NP]' in a rule means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

### 1. Rules

- 1.1. The event is governed by the rules defined in *The Racing Rules of Sailing (RRS)*.
- 1.2. Appendix B, Windsurfing Fleet Racing Rules, and Appendix F, Kiteboarding Racing Rules, will apply.
- 1.3. RRS 40.1 will apply.
- 1.4. RRS Appendix P5 may apply for the 29er class. The recommended wind speed for Class Rule C1.1 (b) is 10 knots.

### 2. Sailing Instructions

- 2.1 The sailing instructions will be available after 1700 hours on Friday, May 20, and may be found online at <https://yachtscoring.com>.
- 2.2 The sailing instructions will consist of the instructions in RRS Appendix S, Standard Sailing Instructions, and supplementary sailing instructions (SSIs) on the official notice board and online at <https://yachtscoring.com>.

### 3. Communication

~~3.1 Notices to competitors will be posted on the Official Notice Board located on the outside wall on the northwest side of the Etobicoke Yacht Club (EYC) clubhouse and online at <https://yachtscoring.com>.~~

### 4. Eligibility and Entry

- 4.1. The event is open to all boats of the 2.4 mR, ILCA 4, ICLA 6, ILCA 7, 49er, 49erFX, 29er, 420, 420 white sail, KiteFoil Open. Additional classes may be added if a minimum of 5 boats register.
- 4.2. Boats in the 420 class may use any recognized 420 hull form and the standard club training rig (with non-tapered mast) and shall have a minimum weight of 100 kg fully rigged for sailing and in dry condition but without sails and personal equipment.
- 4.3. Boats may only enter the event by registering online at <https://yachtscoring.com>.
- 4.4. Competitors under the age of 18 years require a parent or guardian (the term 'guardian' can be extended to include a coach or chaperone traveling with the competitor) to sign a waiver form acknowledging and accepting the risks inherent in the competitor's participation in the event, whether on or off the water.



- 4.5. To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.6. Registration may be limited depending upon the COVID restrictions and practices at the time of the event.

## 5. Fees & Registration

- 5.1. The registration fee is \$95 per singlehanded boat (includes HST) and \$115 (includes HST) per doublehanded boat; and includes dinner on the Saturday night.
- 5.2. The registration fee is \$75 per KiteFoils & 2.4mR (includes HST) and does not include dinner.
- 5.3. Registration will close at 1200h on Fri, May 20<sup>th</sup>, 2022.
- 5.4. Entry fee refunds may be granted at the discretion of the OA. An administrative fee may be applied.
- 5.5. Saturday night dinner tickets are available for \$20 each.

## 6. Advertising [DP]

- 6.1 Competitors may be required to display advertising chosen and supplied by the Organizing Authority.
- 6.2 Numbered bibs will be provided for KiteFoil competitors, which must be worn while racing.

- 7.3 On the last scheduled day of racing, no warning signal will be made after 1500 hours.

## 8. Equipment Inspection

- 8.1 Boats may be inspected at any time.
- 8.2 Competitors are responsible for ensuring their boats meet the measurement standards as prescribed by the class association.

## 9. Venue

- 9.1 The Etobicoke Yacht Club is located at 300 Humber Bay Park Road West, Toronto, Ontario, Canada, M8V 3X7, 416-259-1159. This is located on Humber Bay at the western edge of Toronto, on Lake Ontario.



- 9.2 Sailing for the KiteFoil Open class will take place on Lake Ontario and, depending on the winds, in the vicinity of Leuty Lifeguard Station (primary location) or Hanlon's Point Beach (secondary location).  
For all other classes, sailing will take place on Lake Ontario adjacent to Etobicoke Yacht Club, with course locations provided in the Supplementary Sailing Instructions.

## 10. Penalty System

- 11.1 RRS Appendix P will apply as changed so that RRS P2.3 will not apply, and RRS P2.2 is changed so that it will apply to any penalty after the first one.
- 11.2 For the KiteFoil Open, 29er, 49er, and 49erFX classes, RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty

## 11. Scoring

- 11.1. One race is required to be completed to constitute a series.
- 12.2 (a) When fewer than five races have been completed, a boat's series score will be the total of her race scores.
- (b) When from 5 to 9 races have been completed, a boat's series score will be the total of her race scores, excluding her worst score.
- (c) When ten or more races have been completed, a boat's series score will be the total of her race scores, excluding her two worst scores.

## 12. Support Person Vessels

- 12.1. [DP] Support person vessels will be assigned a berth or mooring area for the duration of the event. Such berth or mooring is subject to the terms and conditions for all boats using EYC-controlled facilities.

## 13. Berthing

- 14.1 [DP] Boats shall be kept in their assigned places while at EYC.
- 14.2 All boats must be removed from all club facilities by Tuesday, May 24, unless a prior written agreement is given by facilities management.

## 14. Risk Statement

- 15.1 RRS 3 states: 'The responsibility for a boat's decision to participate in a race or to continue to race is hers alone.' Each competitor agrees and acknowledges that sailing is a potentially dangerous activity with inherent risks in participating in this event. These risks include strong winds and rough seas, sudden changes in weather, failure of equipment, boat handling errors, poor seamanship by other boats, loss of balance on an unstable platform, and fatigue resulting in an increased risk of injury. The Club and Organizing Authority is not responsible for any risk to competitors due to their participation.
- 15.2 By coming onto EYC property and or participating in EYC events, boats agree to release EYC and its members, servants, and agents from liability arising from contracting COVID-19 as a result thereof.

## 15. Insurance

- 15.1. Each participating boat shall be insured with valid third-party liability coverage of two million dollars (\$2,000,000) CAD per incident.
- 15.2. The club or school with which a competitor is affiliated will be responsible for the financial obligations associated with any incident in which the competitor is found to be at fault.

## 16. Prizes



- 16.1. Prizes will be given to boats placing first, second and third in each class with five or more entries; to those placing first and second in classes with four entries and to the first-place crew in classes with three entries.
- 16.2. For the 29er, ILCA 6, and ILCA 7 classes, this is an Ontario Team Canada Summer Games qualifying event.
- 16.3. Other prizes may be awarded.

## 18. Concussion Awareness

- 18.1 [DP] Certain aspects of Rowan's Law are in effect. To review current information and requirement, check the Ontario Sailing website: <https://ontariosailing.ca/concussion-information/>
- 18.2 [DP] Any participant who registers with or enters the event needs to do the following:
  - Confirm you have read the Ministry Approved Concussion Awareness Resource.
  - Confirm you have reviewed, and committed to, the Ontario Sailing Athlete Concussion Code of Conduct.
- 18.3 [DP] Coaches/Instructors must also complete both items below.
  - Confirm they have read the Ministry Approved Concussion Awareness Resource.
  - Confirm they have reviewed, and committed to, the Ontario Sailing Coach Concussion Code of Conduct.
