2 NOTICES TO COMPETITORS

Notices to competitors will be posted on the online official notice board located at https://yachtscoring.com/emenu.cfm?eid=15120.

4 SIGNALS MADE ASHORE

4.1 Signals made a shore will be displayed at the WYC west flag pole directly to the west of the clubhouse as indicated in NOR Addendum A – Venue.

7 RACING AREA

NOR Addendum B shows the location of the racing area. The racing area is centred approximately 1.7 nm on a compass bearing of approximately 150° M from the Whitby Harbour East Pier Head light.

8 THE COURSES

8.4 For courses L, LA and TL, the starting line and finishing line will follow the diagram to the right. This changes the course diagrams for courses L, LA and TL in RRS S. Both the starting and finishing marks may be in place during a start or a finish.



9 MARKS

- **9.1** Marks 1, 2p and 2s will be yellow tetrahedrons.
- **9.2** The offset mark 1a will be a red ball.
- **9.3** New marks as provided in instruction 12.1 will be orange tetrahedrons.
- **9.4** The starting marks will be the race committee signal boat at the starboard end and orange tetrahedron at the port end.
- **9.5** The finishing marks will be the race committee signal boat at the starboard end and a pin with blue flag at the port end.

11 THE START

11.1 The starting line will be between a staff displaying an orange flag on the starboard end signal boat and the course side of the port-end starting mark.

12 CHANGE OF THE NEXT LEG OF THE COURSE

12.4 Courses will not be shortened to less than 2 legs in length. The leg to 1a is not considered a leg of the course for this purpose. This changes SSI 12.4

13 THE FINISH

13.1 The finishing line will be between a staff displaying a blue flag on the starboard end signal boat and the course side of the port-end finishing pin.

15 PROTESTS AND REQUESTS FOR REDRESS

- **15.1** The race office is located online at https://yachtscoring.com/emenu.cfm?eid=15120. Protests and requests for redress are initiated from within the Owner's Corner.
- **15.3** Arbitration meetings and hearings will be held in the Whitby Yacht Club Sailing School to the north west of the clubhouse as indicated in NOR Addendum A Venue.
- **15.6** Arbitration under RRS T will apply. Penalty acceptance forms are available at the race office. The Arbitrator may subsequently sit on the Jury hearing the protest.

Prizes will be given as follows:

- (a) The winner of the regatta will be awarded the Gold Cup Trophy.
- (b) Keeper prizes will be awarded to the top 5 skippers and crew.
