1. RULES

1.1 The U.S. Sailing Association's Racing Rules of Sailing 2020-2024 edition will govern this regatta.

2. ELIGIBILITY

2.1 All competitors must:

2.1a Be members in good standing of Breakwater Yacht Club

2.1b Have paid the entry fee

2.1c Have completed the entry form and registration at Breakwater Yacht Club 2022 May Cup Yachtscoring page

2.1d Have boat insurance covering racing

2.1e Hold a valid **ELIYA PHRF 2022 certificate**

2.2 Visiting yachts may enter at a cost of \$20.00 per individual race but will not be scored for the series.

2.3 Eligibility to race for visiting yachts is up to the discretion of the Regatta Committee.

2.4 **No competitor will be scored without fulfilling all eligibility requirements prior to the race.**

3. FEES

3.1 \$50 for US Sailing Members

3.2 \$55 for non-US Sailing members

3.3 All Registration needs to be done through the Breakwater Yacht Club 2022 May Cup Yachtscoring page

Division 1 (Spinnaker)

Division 3 (Non-Spinnaker)

Division 4 (J70)

6. COURSES

6.1 All races will be run in Shelter Island Sound.

6.2 Courses will be displayed from a board on the committee boat.

7. START

The start shall be in the area west of Majors Cove in Shelter Island Sound. The RC shall attempt to sound the first gun at 6:00 PM local time.

8. SCORING

8.1 All classes will be scored using time on time, except Div. 4

9. PRIZES

Prizes will be awarded for 1st, 2nd, and 3rd place will be awarded in all divisions

Changes to the Notice of Race and the Sailing Instructions may be posted on the official notice board at the BYC Clubhouse and/or Breakwater Yacht Club 2022 May Cup Yachtscoring
