#### 1 RULES

- 1.1 The event is governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 The current PHRF Regulations as administered by the YRA of LIS will apply.
- 1.3 Boats shall observe the current US Sailing Special Equipment Requirements for Nearshore races, however section 2 and 3 shall not apply to boats not designed and equipped with: pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.4 Rule V, Alternative Penalties, will apply.  
Appendix T will apply as changed below:  
After the last sentence of appendix T4, Arbitration Meeting Outcomes, add the following:  
If a protest hearing is held, the arbitrator will not be a member of the panel that hears the protest but will be permitted to observe the testimony presented and offer evidence. This changes rule T4 and rule 63.3(a).

- 3.3 On the water, the race committee will make courtesy broadcasts to competitors via VHF.
- 3.4 [DP] While racing, From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to Offshore One Designs, Racer-Cruisers and Non-Spinnaker Boats. For those classes not sailing One-Design under class rules, entries shall be accompanied by a valid YRALIS PHRF certificate.
- 4.2 For Non Spinnaker, a minimum of 5 entries shall be received by 1700, Wednesday, July 12, 2023 for a separate start.
- 4.3 Eligible boats may enter by registering online at [https://yachtscoring.com/event\\_registration\\_email.cfm?eid=15729](https://yachtscoring.com/event_registration_email.cfm?eid=15729) no later than 1700 Wednesday, July 12, 2023.
- 4.4 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.

The entry fee is \$50.00 if paid before 1700, Wednesday, July 12, 2023.  
The entry fee is \$75.00 if paid after 1700, Wednesday, July 12, 2023.  
The entry fee includes awards and beer following the completion of racing.

- 10.2 A boat which sets a new elapsed time long course record in the Execution Rocks Race will receive a case of Mt. Gay Rum. The elapsed time record for the long course is 1:00:48, set by Sundari on July 21, 2019.
- 10.3 Prizes will be awarded following the completion of racing, Friday, July 14, on the front lawn

- 3.3 On the water, the race committee will make courtesy broadcasts to competitors on VHF radio. The channel will be 73.
- 3.4 [DP] While racing, From the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 ELIGIBILITY AND ENTRY

- 4.1 The event is open to Offshore One Design Racer-Cruisers, Double Handed and Non-Spinnaker Boats. At the discretion of the race committee, some divisions may be divided into separate classes. Non-Spinnaker Boats will race with the navigator course.
- 4.2 For those classes not sailing One-Design, entries shall be accompanied by a valid YRALIS PHRF (PHRF) certificate or ORC International (ORCi) certificate. A minimum of 5 boats are required for a class.
- 4.3 Eligible boats may enter by registering online at [yachtscoring.com](https://www.yachtscoring.com) no later than Wednesday July 12, 2023.
- 4.4 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.
- 4.5 Teams of at least 2 yachts, in separate classes (cruising, one design, Ideal 18) and along with at least 1 Team Race entry, will be eligible for the Larchmont Race Week Club Champion Trophy

#### 5 FEES

- 5.1 The entry fee is \$150.00. Entry fee after Wednesday, July 12 is \$175.00.
- 5.2 The entry fee includes live music ashore, beer, Mt Gay Tent (Sat) and awards presentation.

#### 6 SCHEDULE OF EVENTS

- 6.1 No later than 1100 on Saturday, July 15 and Sunday, July 16, the race committee will announce via Yacht Scoring, the scheduled first warning time of either the earlier initial 1<sup>st</sup> warning or later option.
- 6.2 The first warning for the Navigation Course will be either 1100 or 1300.
- 6.3 For ORCi, PHRF and One Design Classes the first warning will be either 1200 or 1400.

#### 7 VENUE

The racing area will be in the waters off Larchmont Harbor

## **8 COURSES**

- 8.1 The **Navigator** class will be around government buoys.
- 8.2 **Courses for all other classes** will be windward/leeward as described in the sailing instructions.

## **9 SCORING**

- 9.1 One race is required to be completed to constitute a series.
- 9.2 A boat's series score shall be the total of her race scores, without exclusion.
- 9.3 ORCi and PHRF, time allowances will be computed using Time on Distance
- 9.4 For the Larchmont Race Week Club Champions, teams will be scored by using the average percentage of their team race score plus their top two team members' percentage placement within their respective classes.

## **10 PRIZES**

- 10.1 Series prizes will be awarded for first, second and third places in each division.
- 10.2 Perpetual trophies will be awarded at the discretion of the race committee.
- 10.3 The Larchmont Race Week Club Champion Trophy will be awarded to the club with the top club team score.

#### 3 COMMUNICATION

3.1 Notices to competitors will be posted on the official notice board (ONB) online at [YachtScoring.com](http://YachtScoring.com)

3.2 Each boat shall carry a VHF radio capable of communicating on VHF 78A.

3.3 On the water, the race committee will make courtesy broadcasts to competitors via the VHF radio.

3.4 [DP] While racing, from the first warning signal until the end of the last race of the day, except in an emergency, a boat shall not make voice or data transmissions and shall not receive voice or data communication that is not available to all boats.

#### 4 ELIGIBILITY AND ENTRY

4.1 The event is open to all boats of the Viper 640, Etchells, International One Designs, Shields, S-Class, J 105, J70, and J 88 class or any other class that qualifies. To qualify for a class for this event, three valid entries, including the entry fee, must be received prior to 1200 Wednesday July 5, 2023.

4.2 Eligible boats may enter by registering online at [yachtscoring.com](http://yachtscoring.com)

4.3 To be considered an entry in the event, a boat shall complete all registration requirements and pay all fees.

4.4 Teams of at least 2 yachts, in separate classes (racer/cruiser, navigator, one designs) along with at least 1 Team Race entry, will be eligible for the Larchmont Race Week Club Champion Trophy

#### 5 FEES

5.1 The entry fee is \$185.00. For the Shields Class, those boats participating only in the Shields Districts the 2nd weekend, the entry fee is \$150.00.

5.2 For any class electing to race one weekend only, the fleet captain must notify the race committee no later than Wednesday, July 5. For those classes, the entry fee is \$150.00.

5.3 Entry Fee includes awards presentations, live music and beer.

#### 6 SCHEDULE OF EVENTS

6.1 No later than 1100 each day, the race committee will announce via Yacht Scoring the scheduled first warning of either 1225 or 1425.

6.2 The race committee intends to run multiple races each day.

The racing area will be in the waters off Larchmont Harbor.

## **8 COURSES**

The courses to be sailed will be windward/leeward, or triangle, windward/leeward, as described in the sailing instructions.

## **9 SCORING**

9.1 One race is required to be completed to constitute a series.

9.2 If fewer than five races have been completed, a boat's series score will be the total of her race scores. If five or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

9.3 For the Larchmont Race Week Club Champions, teams will be scored by using the average percentage of their team race score plus their top two team members' percentage placement within their respective classes.

## **10 PRIZES**

10.1 Series prizes will be awarded for classes that qualify in NoR 4.1. Prizes will be awarded to first, second, and third place boats following the completion of racing on the front lawn, Sunday, July 23, 2023.

10.2 Perpetual trophies will be awarded at the discretion of the race committee.

10.3 The Larchmont Race Week Club Championship Trophy will be awarded to the club with the top club team score.

##### **4 ELIGIBILITY AND ENTRY**

- 4.1 The event is open to all boats of the Ideal 18 class.

##### **6 CHARTERED BOATS**

- 6.1 Most of the boats sailing in this event are expected to be owned by skippers' yacht clubs. Skippers are encouraged to arrange with their own clubs to sail boats owned by their clubs.
- 6.2 For skippers who are unable to arrange boats owned by their clubs, the OA and other area yacht clubs will make their Ideal 18s available for charter on a first-come basis. Boat charter must be selected during online registration. Please see the separate Boat Charter Document posted on the Notice board.
- 6.3 Boat charters will be managed by the OA. Participants will be notified of the boat they will sail at registration. Chartered boats are provided "as is" and will include sails and all required safety equipment. Charterers are encouraged to provide their own sails and to inspect their boats prior to sailing to determine if they wish to add any spare or extra gear.
- 6.4 An additional Waiver form regarding personal injury and chartered boat responsibility must be signed at registration.
