# **MOUNT GAY RUM & SAILING WORLD**

#### 1. RULES

- **1.1** This regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS).
- **1.2** Boats are urged to refrain from displaying advertisements for businesses or products competing with those of the primary and support sponsors of the event.
- **1.3** Rules I.1 and I.3 of the J/70 Class Rules Part III-Section I shall apply.
- **1.4** The US Sailing Prescriptions to RRS 60, 63.2, and 63.4 shall not apply.

# 2. ENTRIES

- **2.1** Eligible boats may be entered by completing registration with the organizing authority.
- **2.2** The Helly Hansen NOOD Regattas are open to those boats whose owner and/or skipper is a current member of their national authority (US Sailing for USA members, to join call 1-800-877-2451).

#### 3. NOTICES TO COMPETITORS

Notices to competitors will be posted on the Official Notice Board located at the AYC Junior Sailing Center, and may be posted electronically on the unofficial notice board located at http://www.yachtscoring.com/emenu.cfm?eID=1590. Links to the unofficial notice board will also be available on the Sailing World Helly Hansen NOOD website (http://www.sailingworld.com/nood-regattas/annapolis) and on the Annapolis Yacht Club (AYC) website (www.annapolisyc.com).

# 4. CHANGES TO SAILING INSTRUCTIONS

Any change to the sailing instructions (SI) will be posted before 0830 hrs. on the day it will take effect, except that any change to the schedule of races will be posted by 2000 hrs. on the day before it will take effect.

## **5. SIGNALS MADE ASHORE**

- **5.1** Signals made ashore will be displayed from the mast at the AYC Junior Fleet Building.
- **5.2** When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 60 minutes' in the race signal AP.
- **5.3** Flag L over numeral pennant "#" with one sound signal means: "Notice to Competitors

Number "#" has been posted." This changes Race Signals L.

# 6 DIVISIONS, CLASS FLAGS, STARTING SIGNALS AND MARKS

Division splits, class flags, starting order and the description of marks will be defined in SI Addendum 1. It will be posted on the official notice board and copies will be available to all competitors at registration.

#### 7. SCHEDULE OF RACES

- **7.1** Ten races are scheduled. No more than two races will be sailed on Sunday, May 1, 2016.
- **7.2** The race committee will rendezvous with each division at 1000 each day. A race committee boat will display flag "L", accompanied by a long sound signal, then proceed to the starting area. Rendezvous locations:

Division 1: 1 nm NE of Severn River dolphin Y"4" Division 2: 1 nm S of Hackett Pt at C"1"

Division 3: Severn River R"2"

Division 4: 0.5 nm E of Thomas Pt. Light.

**7.3** The scheduled time of the warning signal for the first start of the first race each day is 1100 hrs. No warning signal will be made after 1430 hours on Sunday, May 1, 2016.

# 8. SAFETY

- **8.1** A boat that retires from a race shall notify the race committee as soon as practicable.
- **8.2** RRS 40 (Personal Buoyancy) is replaced by: "It shall be the individual responsibility of each competitor to wear adequate personal buoyancy when conditions warrant."
- **8.3** Boats shall not exercise right of way, cross in close proximity to, or interfere with the reasonable transit of the race area by a freighter, tug or other commercial vessel. Boats must take corrective action well in advance of any potentially dangerous situation. The race committee or protest committee may protest a boat for breaking this instruction based on information received from any source. The protest time limit does not apply. This changes RRS 60.2, 60.3 and 61.3.

## 9. COURSES

9.1 The courses, including rounding side

- and order, are as shown in the diagrams and descriptions.
- **9.2** The starting line signal boat will display boards showing the course to be sailed, the approximate distance (nm) between the windward and leeward mark the magnetic bearing of the first mark.
- **9.3** The leeward mark may be a gate. In the event that the gate is not in place, boats shall round the existing leeward mark to port.
- **9.4** When the first mark of the course is to be a change mark, flag C will be displayed by the starting line signal boat before the warning signal, accompanied by a series of repetitive sound signals.

#### 10. THE START

- **10.1** The starting line will be between the hoist of the orange flag on the signal boat and the course side of the port-end starting mark or the hoist of the orange flag on a pin boat.
- **10.2** The starting area is defined as extending 100 yards beyond each end of the starting line and 150 yards behind the starting line and its extensions. Boats shall keep clear of the starting area and the first leg of the course until their warning signal has been made.
- **10.3** A race committee starting or finishing boat may set a stand-off buoy. When present, this stand-off buoy, the line attaching it to the race committee boat, and the race committee boat are all part of the starting or finishing mark.
- **10.4** If flag U has been displayed as the preparatory signal, no part of a boat's hull, crew, or equipment shall be in the triangle formed by the ends of the starting line and the first mark during the last minute before her starting signal. If a boat breaks this rule and is identified, she shall be disqualified without a hearing but not if the race is restarted or resailed or postponed or abandoned. RRS 29.1 does not apply. The scoring abbreviation is UFD (Disqualification under SI 10.4). This changes RRS 26, 29.1, 63.1, A5 and A11.
- **10.5** The race committee may set a small spherical buoy as a mid line guide, near the middle of the starting line. This is neither a starting mark nor a mark of the course.

#### 11. RECALLS

The race committee intends to announce boats identified as OCS on VHF radio. Division 1 will broadcast on VHF 68, Division 2 on VHF 69, Division 3 on VHF 72, Division 4 on VHF 73. Failure to transmit information, receive such notification, or the order in which recalled boats are broadcast will not be grounds for redress. This changes RRS 62.

### 12. CHANGE OF POSITION OF THE NEXT MARK

- **12.1** New marks are described in SI Addendum 1. When in a subsequent change of course a new mark is replaced, it will be replaced with an original mark.
- **12.2** When flag Q is displayed with flag C, the change will apply only to boats beginning their final leg to the finish. This changes RRS 33 and Race Signals.

## 13. THE FINISH

- **13.1** The finishing line will be between the hoist of the blue flag on the race committee boat and the course side of the nearby finishing mark.
- **13.2** For Courses "4" and "6", the finishing mark will be placed on the side of the RC Boat opposite that of the starting mark.

## 14. TIME LIMIT

- **14.1** The time limit for the first boat to sail the course as required by RRS 28.1 and finish is 2 hours.
- **14.2** Boats still racing 30 minutes after the first boat in that class finishes will be scored TLE (Time Limit Expired, see Scoring) and should proceed to the starting area if another race is scheduled. The race committee boat at the finishing line will lower the blue shape or flag with a long sound signal when the 30 minute period has expired for all classes. This changes RRS 35.

# **15. PENALTY SYSTEM**

- **15.1** Penalties while racing: For the Farr 30, Melges 14, Melges 32, and S2 7.9 classes only, RRS/US Appendix T, Section A (Penalties While Racing) will apply. For all other classes RRS 44.1, One-Turn and Two-Turns Penalties will apply.
- **15.2** Penalties after racing: RRS/US Appendix T, Sections B (Post-Race Penalties) and D (Arbitration) will apply.

#### 16. PROTESTS

**16.1** Protest forms are available at the protest desk located at the AYC Junior Fleet

Building. Protests and requests for redress or reopening shall be delivered there within the appropriate time limit.

- **16.2** The protest time limit is 60 minutes after a division's race committee signal boat docks. The race committee will post the protest time limit.
- **16.3** The race committee will post a list of boats with assigned starting or finishing penalties no later than the protest time limit.
- **16.4** Notices of protests by the race committee or protest committee will be posted to inform boats under RRS 61.1(b).
- **16.5** As soon as practicable after the protest time limit, the protest committee will post a notice to inform competitors of the schedule of hearings and arbitration meetings in which they are parties or named as witnesses. Hearings will be held at the AYC Junior Fleet Building.
- **16.6** The penalty for breaking SIs 1.3, 8.1, 10.2, 18, 19.2, or NOR 2, or RRS 55 may be less than disqualification if the protest committee so decides.
- **16.7** On the last day of the regatta, the time limit for requesting redress or reopening a hearing is one hour after the decision is announced or the protest time limit, whichever is later. This changes the time limits in RRS 62.2, the US Sailing prescription to RRS 62.2 and RRS 66.

#### 17. SCORING

**17.1** One completed race shall constitute a series. **17.2** A boat's series score will be the total of her race scores without discard. This changes RRS A2. **17.3** Boats to be scored TLE and not thereafter retiring, being penalized, or given redress will be scored points equal to the number of boats finishing within the time limit plus two points by the race committee without a hearing. This changes RRS A4.1, A4.2 and A5.

# 18. BOW STICKERS

Easily removable bow stickers provided in the Skipper's package, shall be attached to the forward 25% of both sides of the boat's hull at all times while racing. The stickers are to be carried with the top approximately 6"-10" below deck level and with the leading edge approximately 10"-20" aft of the bow.

#### 19. RADIO COMMUNICATIONS

**19.1** The race committee may attempt to provide information on VHF radio as a courtesy. In all cases race signals shall govern. Division 1 will broadcast on VHF 68, Division 2 on VHF

69, Division 3 on VHF 72, Division 4 on VHF 73. Failure to transmit information, or errors in transmitting information, will not be grounds for redress. This changes RRS 62.

**19.2** A boat may not make any radio transmissions while racing except on VHF 16 or with the race committee on the courtesy broadcast channel for their division. While racing, a boat shall not receive ANY communication not available to all boats. This restriction includes mobile devices.

#### 20. PRIZES

**20.1** Overall series prizes will be awarded by class. **20.2** An award will be made to the boat which, in the opinion of the organizing authority, had the best overall performance during the 2016 Helly Hansen NOOD Regatta in Annapolis.

#### **21. MEDIA AND TELEVISION**

Competitors give absolute right and permission for any photograph and video footage taken of themselves or the boat they are sailing during the event, to be published in any media whatsoever, for either editorial or advertising purposes or to be used in press information.

## 22. DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

# 23. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$500,000 per event or the equivalent.

# 24. COMPETITORS' CONDUCT

The skipper shall be responsible for the conduct of the crew before, during and after racing. In case of conduct that the organizing authority considers to be a gross breach of good manners or sportsmanship, destruction of property or failure to comply with a reasonable request by the organizing authority, protest committee, or race committee, the boat whose crew was at fault may subject to action by the protest committee under RRS 69. It is the protest committee's intention to act under RRS 69 in appropriate cases.



The Helly Hansen NOOD Regattas are official US Sailing sanctioned events.

# COURSE DIAGRAMS



# COURSE 3

"3" (three legs): This course is windward, leeward, finish to windward. The marks shall be rounded in order of 1,2, finish. Mark 2 may be left on either hand on the first windward leg and Mark 1 may be left on either hand on the finishing leg.

# COURSE 4

"4" (four legs): This course is a windward, leeward, twice around, finish to leeward. The marks will be rounded in the order of 1, 2, 1, finish. Mark 2 may be left on either hand on the first windward leg and on the finishing leg.

# COURSE 5

"5" (five legs): This course is a windward, leeward, twice around, finish to windward. The marks shall be rounded in the order of 1, 2, 1, 2, finish. Mark 2 may be left on either hand on the first windward leg and Mark 1 may be left on either hand on the finishing leg.

# COURSE 6

"6" (six legs): This course is a windward, leeward, three times around, finish to leeward. The marks shall be rounded in the order of 1, 2, 1, 2, 1, finish. Mark 2 may be left on either hand on the first windward leg and on the finishing leg.
