



NOR Amendment #1 -

NOR 1.2 - Onshore functions will be hosted at Sail Newport unless posted otherwise.

1.2 has been amended to the following -

Onshore regatta and social functions will be hosted at the Newport Shipyard. Changes to regatta headquarters will be posted on the regatta website.

NOR Amendment #2 -

NOR 1.3 - Dockage for all competitors shall be at the Alofsin Piers at Sail Newport.

1.3 has been amended to the following -

Dockage for all competitors shall be at designated dockage at the Newport Shipyard.

NOR Amendment #3 -

7.FEES

7.1. The entry fee is US \$1,900 for entries received prior to July 1. For entries received between July 1 and August 1, the fee shall be US \$2,000. For entries received between August 1 and August 27th, the fee shall be US \$2,100. This entry fee includes dockage between September 24th and October 3rd, launching and hauling of competing boats, professional race management, class employees and 8 tickets to all class sanctioned social events.

7.1 has been amended to the following -

The entry fee is US \$1,900 for entries received prior to July 1. For entries received between July 1 and August 1, the fee shall be US \$2,000. For entries received between August 1 and August 27th, the fee shall be US \$2,100. This entry fee does not include dockage at the Newport Shipyard, launching or hauling. Teams may launch and haul at the Newport Shipyard or Sail Newport, however all boats are required to dock at the Newport Shipyard from Monday, September 26th to October 2nd.

Entry fee includes admission to all World Championship Social Events, professional race management, jury/umpire expenses, RC boat used and maintenance, and class administration.



7.2 - Teams are responsible for any costs other than those described in NOR 7.1 such as launching and hauling of support boats and trailer storage.

7.2 has been amended to read -

Teams are responsible for any costs other than those described in NOR 7.1. Launching, hauling and dockage of tenders and coach boats, trailer storage and any services needed for additional equipment is not included in the entry fee.

NOR Amendment #4 -

18. LAUNCHING AND BERTHING

18.1 As part of the entry fee, each boat shall be provided with dockage at Sail Newport. All competitors must use dockage provided at Sail Newport.

18.1 has been amended to the following -

Teams may launch/haul and store trailers at Sail Newport, however dockage is required at the Newport Shipyard from Monday, September 26th to October 2nd. Dockage, launching and hauling at the Newport Shipyard is not included in the entry fee. Individual teams are responsible for arranging individual payment with the Newport Shipyard.

18.2 Each team is responsible for making its own arrangements for launching/hauling, trailer storage, work trailer storage, RIB/support boat and trailer storage. Dockage and trailer space will be provided by Sail Newport for an additional fee.

Each team is responsible for making its own arrangements for launching/hauling, trailer storage, work trailer storage, RIB/support boat and trailer storage. Dockage for tenders or additional support boats is available at the Newport Shipyard or Sail Newport for an additional fee.
