## SAILING INSTRUCTIONS RACE AREA 1

#### HARBOR 20, MELGES 15, SNIPE and J/22

#### 1 RULES

Racing will be governed by the *rules* as defined in the current *Racing Rules of Sailing* (RRS) except as modified by the NOR or these Sailing Instructions. These sailing instructions supersede the CBYRA GSI as published in the Green Book.

#### 2 NOTICES TO COMPETITORS

Notices to competitors will be posted on the Electronic Notice Board located on the Regatta Website <u>https://yachtscoring.com/emenu.cfm?elD=16653</u>.

#### 3 CHANGES TO THE SAILING INSTRUCTIONS

Any change to the Sailing Instructions (SIs) will be posted before 0900 hours on the day of the race, except that any change to the schedule of races will be posted by 2000 hours the day before it will take effect.

#### 4 POSTPONEMENT ASHORE

- 4.1 A Postponement ashore, along with a new intended start time, may be announced on the competitors' VHF channel 69 and posted on the Regatta Website.
- 4.2 A Postponement ashore will end not less than 60 minutes before the new intended start time. This changes RRS Race Signals.

#### 5 SCHEDULE OF RACES

- 5.1 Three (3) to five (5) races are scheduled. However, fewer races may be sailed depending on conditions and one race will be sufficient to constitute a regatta.
- 5.2 Competitors' rendezvous will be at **1130** hours in the Severn River, 100 yards southeast of the Horn Point Shoal Mark ("HP," FI W 6.0s)
- 5.3 Check-in with the Race Committee signal boat is required. Please hail the RC with your sail number when passing astern of the signal boat on starboard tack. This check in shall be acknowledged by the RC.
- 5.4 The Warning Signal for the first race is intended to be made at 1200 hours.
- 5.5 No Warning Signal shall be made after 1530 hours.
- **6 RACING AREA** -The racing area will be in the Severn River south of the main channel, between the entrance channel to Annapolis Landing and the entrance channel to Lake Ogleton.

#### 7 THE COURSE

- 7.1 The course shall be a windward-leeward course with start and finish in the middle and three legs as shown in Appendix A.
- 7.2 The start and finish lines are closed on the downwind leg.
- 7.3 All rounding marks shall be kept to PORT.

#### 8 MARKS

The start/finish, windward and leeward marks will be pale red "hippetty-hop" balls approximately 24 inches in diameter.

#### 9 THE START

- 9.1 Starting order shall be J/22, Harbor 20, Melges 15, Snipe for the first race. Subsequent starts will be announced via VHF radio and may change order.
- 9.2 The starting line shall be between the hoist of an orange flag on the RC Signal Boat and the course side of a set mark.
- 9.3 The class in sequence will be announced via VHF radio.
- 9.4 Races will be started as per Appendix U. This changes RRS 26.
- 9.5 Starts will not be rolling between classes.

#### 10 RECALLS

- 10.1 The Race Committee will attempt to notify boats identified as OCS by announcing their racing numbers verbally and on VHF 69. Failure to transmit or receive such notification will not be grounds for redress. This changes RRS 62.
- 10.2 In the event of a General Recall, the Race Committee will hail verbally and on VHF channel 69. The Race Committee may or may not display the flag First Substitute or the sound signals. This is not subject to redress. A general recall will send that class to the back of the starting order.

#### 11 THE FINISH

11.1 The finish line shall be between the hoist of a blue flag on a RC Boat and the course side of a course mark.

#### 12 TIME LIMIT

- 12.1 If no boat in a class finishes within one (1) hour of the class start, the race shall be abandoned.
- 12.2 Boats failing to finish within 30 minutes after the first boat that sails the course and finishes shall be scored Time Limit Expired (TLE). This changes RRS 35 and A4. Boats leaving the course without finishing shall promptly notify the Race Committee on VHF channel 69.

#### 13 PENALTY SYSTEM

Appendix V1 shall apply

#### 14 PROTESTS AND REQUESTS FOR REDRESS

- 14.1 RRS 61.1(a) is changed to "As a courtesy, the race committee requests (but does not require) that competitors notify them on VHF 72 of their intent to protest another boat."
- 14.2 Protests or requests for redress shall be filed online (<u>https://yachtscoring.com/race\_forms.cfm</u>) and are due via email to <u>scc1944.rc@gmail.com</u> within one hour after the Race Committee signal boat docks. This changes RRS 62.2.
- 14.3 Notices of protests by the RC or PC will be posted on the Official Notice Board and emailed to inform boats under RRS 61.1(b).
- 14.4 Notice(s) will be posted soon after receipt to inform competitors of hearings in which they are parties or named witnesses. *Protest hearings are intended to be held virtually; all parties will be emailed with details.*

#### 15 SCORING

- 15.1 RRS Appendix A4, Low Point System, will apply.
- 15.2 Boats to be scored TLE and not being penalized or given redress will be scored points equal to the number of boats finishing within the time limit, plus two points, by the Race Committee, without a hearing. This changes RRS A4.2 and A5.

#### 16 SAFETY REGULATIONS

- 16.1 Boats shall check in with the Race Committee Signal Boat prior to their first start of the day by hail of their sail number and an acknowledgement from the RC.
- 16.2 All boats shall carry a VHF radio capable of communicating on VHF channels 9, 13, 16 and 69, the Area 1 RC channel.
- 16.3 A boat that retires from a race or leaves the racing area before the end of racing, shall notify the RC at the first reasonable opportunity.
- 16.4 Penalties for breaking SIs 16.1, 16.2, 16.3, or RRS 55 may be less than disqualification if the protest committee so decides.

#### 17 RADIO COMMUNICATIONS

- 17.1 The RC will communicate with competitors in Area 1 on VHF channel 69.
- 17.2 Boats are encouraged to make contact with commercial traffic on VHF channel 13, as required for safety.
- 17.3 Failure to hear a broadcast, the RC's failure to broadcast, or the content of any broadcast shall not be grounds for redress.

#### 18 COMMERCIAL TRAFFIC

- 18.1 A boat may not exercise right of way, cross in proximity to, or interfere with reasonable transit of the race area by commercial traffic. A boat protested under this rule has the burden of proof that she complied with this rule. Boats shall take evasive action well in advance of any potential situations. The U.S. Coast Guard, ship captains, and bay pilots have been encouraged to report any incident they observe.
- 18.2 Boats may not protest other boats for breaking SI 18.1. This changes RRS 60.1.
- 18.3 The RC or PC may protest under SI 18.1, based on information received from any source. There is no time limit for protests filed under SI 18.1. This changes RRS 60.2, RRS 60.3, and RRS 61.3.
- 18.4 RRS 42.3 (Propulsion Exceptions) is changed by adding: "(j) A boat that is without way in a ship channel may use any means of propulsion to clear the channel at the approach of commercial traffic provided that, when becoming clear of the commercial traffic, the boat has not improved their position as a result of this action. A boat claiming this exception shall report the incident in writing to the protest committee within the protest time limit, with all the facts necessary to substantiate the boat's speed and change of position during the incident."
- 18.5 RRS 62.1 (Redress) is changed by adding: "(e) clearing a ship channel in compliance with SI 18.4."

#### 19 PRIZES & SHORE PARTY

- 19.1 Prizes in each class will be given as follows to 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place finishers.
- 19.2 Sponsored trophies are underwritten by multi-year pledges from corporate or individual sponsors.
  - Sajak Family Foundation Trophy awarded for the best performance in Cruising One Design.
  - Geri Manning Memorial Trophy awarded for the racing crew raising the most money.
  - **Donnybrook-Brendan Trophy** awarded to the team with the highest percentage of youth crew participation.
  - The Van Metre Family Trophy awarded to the best performance in entire Hospice Cup Fleet
  - **The Hospice Cup** is the top honor awarded for best three-year performance. It qualifies the winner to compete in the annual Hospice Regattas National Championship against representatives of the many other hospice regattas sailed nationwide, each event patterned on this original hospice regatta.
  - Annapolis Triple Crown Charity Trophy This trophy is a partnership between the Maryland Cures Cancer Regatta, CRAB Regatta and Hospice Cup. Racers must participate in each of the three charity regattas and fundraise. The calculation for the winner shall be the order of finish in each race and the amount of funds raised for each race. The amount of funds raised shall be given a higher multiplier (1.5) in the calculations. The skipper with

best score in the three races and highest fundraising will be awarded the Triple Crown of Charity Sailing Trophy in October sponsored by Weems & Plath.

19.3 **The post-race shore** party and award pickup will be at Horn Point Marina from 1730 to 2100. Complimentary oysters, appetizers, and cake will be first come first served. Christian Douglas from burgers. will also be onsite making smash burgers. Proceeds from the sale of the day's burgers go directly to Hospice Cup to support its partner charities. Donations and tips are strongly encouraged at the bars.


#### 22 SUSTAINABILITY

The Hospice Cup is a Registered Clean Regatta; we place a high priority on care and stewardship of local environment and wildlife. As skippers and competitors think about their own role in protecting our shorelines and the greater Chesapeake Bay Watershed, they should encourage their crews to avoid single-use plastic bottles and instead bring reusable water bottles to this year's race. Plastic straws, bags, and other single-use plastics should be discouraged aboard all participating boats. Furthermore, RRS 55 prohibits placing trash in the water. Crews are also encouraged to retrieve any trash items seen floating in the vicinity of the racecourse, on the way out, and on the way back. Trash items leftover from crew meals or other provisioning should be disposed of responsibly onshore. Small quantities of biodegradables items accumulated underway can be brought to our composting totes at the shore party for disposal if desired.

# SAILING INSTRUCTIONS

**RACE AREA 2** 

(Hospice, PHRF, Cal-25, J-80, CRCA & Others using Govt. Mark courses.)

#### 1 RULES

Racing will be governed by the *rules* as defined in the current *Racing Rules of Sailing* (RRS) except as modified by the NOR or these Sailing Instructions. These sailing instructions supersede the CBYRA GSI as published in the Green Book.

#### 2 NOTICES TO COMPETITORS

Notices to competitors will be posted on the Electronic Notice Board located on the Regatta Website <u>https://yachtscoring.com/emenu.cfm?elD=16653.</u>

#### 3 CHANGES TO THE SAILING INSTRUCTIONS

Any change to the Sailing Instructions (SIs) will be posted before 0900 hours on the day of the race, except that any change to the schedule of races will be posted by 2000 hours the day before it will take effect.

#### 4 POSTPONEMENT ASHORE

- 4.1 A Postponement ashore, along with a new intended start time, may be announced on the competitors' VHF channel 71 and posted on the Regatta Website.
- 4.2 A Postponement ashore will end not less than 60 minutes before the new intended start time. This changes RRS Race Signals.

#### 5 SCHEDULE OF RACES

- 5.1 The starting times for each boat in the hospice class will be posted online by Friday at 1600. Further details may be posted on line after entry registration is completed.
- 5.2 The HOSPICE, PHRF, CAL 25, J/80 and CRCA classes shall compete in one (1) race.
- 5.3 Competitors shall rendezvous at 1100 hours in the vicinity of R2, FI 2.5s (CBYRA "X").
- 5.4 Check-in with the Race Committee signal boat is required. Please hail the RC on VHF channel 71 when you are within 100 feet – this will also serve as a radio check for each vessel.
- 5.5 The Warning Signal for the first **PHRF/CRCA** class race is intended to be made at 1125 hours.
- 5.6 The Warning Signal for the first **Hospice** class race is intended to be made at 1200 hours.
- 5.7 No Warning Signal shall be made after 1400 hours.

- 5.8 All HOSPICE, CAL 25 and J/80 class competitors need not display a class flag or streamer.
- 5.9 All CRCA classes competitors shall display from the backstay a white flag.
- 5.10 All PHRF (A,B,C,N) classes shall display from their backstay their class flag as specified in the CBYRA General SI 8.
- 6 RACING AREA 2 - Chesapeake Bay, off Annapolis, North and East of R2 (CBYRA mark "X")

#### THE COURSES 7

- 7.1 RC shall announce on VHF 71 one of FOUR possible courses to be sailed for the CRCA/PHRF/CAL 25 classes LONG (7.92 NM) or SHORT (5.82 NM); Only the shorter course (5.82 NM) will be used for the Hospice Classes. Boats will sail clockwise around the Green "S" course leaving marks to Starboard or they will sail counter clockwise around the Red 'P" course leaving marks to Port.
- The four (4) possible courses for the CRCA/PHRF/CAL 25/J/80 classes are: 7.2

### LONG

#### **RED "P" COURSE**

START - WR87 - G91 - GC1 - FINISH All rounding marks shall be kept to port. The LONG course is approximately 7.92 nm.

#### SHORT

#### **RED "P" COURSE**

START - WR87 - GC1 - FINISH All rounding marks shall be kept to port.

7.3 The two (2) possible courses for the **Hospice** classes are:

**RED "P" COURSE** 

START – WR87 – GC1 – FINISH All rounding marks shall be kept to port.


**GREEN "S" COURSE** START - GC1 - WR87- FINISH

All rounding marks shall be kept to starboard. The SHORT course is approximately 5.82 nm.

**GREEN "S" COURSE** 

START -GC1- WR87- FINISH All rounding marks shall be kept to starboard. The HOSPICE course is approximately 5.82 nm.

#### **GREEN "S" COURSE** START- GC1 - G91 - WR87-FINISH All rounding marks shall be kept to starboard.

#### 9 The CRCA/PHRF & OTHERS START

- 9.1 A notice of intended starting order will be posted by **1600 September 13 2024**
- 9.2 The start line shall be between the hoist of an orange flag on the RC boat and the course side of **R2**, **FI 2.5s** (CBYRA "X").
- 9.3 For classes, **Other than Hospice Classe**s, Rule 26 of the RRS will be used for starting with the exception that all flags will be verbalized via VHF radio and will not be displayed. There will be a horn blast at each interval, which will take precedence for timing.
- 9.4 The first warning signal for CRCA/PHRF is scheduled for 1125 hours.
- 9.5 The Race Committee will attempt to notify boats identified as OCS by announcing their racing numbers on VHF 71. Code flag "X' will be displayed for individual recall in the event of one or more OCS starters. Failure to transmit or receive such notification will not be grounds for redress. This changes RRS 62.

#### 10 THE <u>PURSUIT</u> START- (11.1 thru 11.10 apply to <u>Hospice classes</u> only)

- 10.1 This shall be a pursuit race with a reverse Assigned Rating Time over Distance (ToD) starting order. The boat with the slowest (largest) rating will start first and the fastest (smallest) shall start last.
- 10.2 The RC intends to signal the starting sequence as follows (this changes RRS 26):

Time	Signal	Sound
1200	Warning signal for all boats	Horn
1201	Preparatory signal for the first boat to start	Horn
1204	One Minute until start	Long horn
1205	Starting signal for the first boat to start	Horn

- 10.3 For the purposes of definition of "racing," each boat's preparatory signal is four (4) minutes prior to her scheduled start.
- 10.4 The start times for all boats will be based on their Assigned ToD handicap. The RC shall use GPS time synchronization.
- 10.5 The start time for each boat, including its time interval from the first start, shall be available Friday evening,13 September or earlier and will be posted on the regatta website.
- 10.6 The start line shall be between the hoist of an orange flag on the RC boat and the course side of mark **R2**, **FI 2.5s** (CBYRA "X").
- 10.7 After the warning signal for the first start, boats shall stay clear of the starting area until 4 minutes before their scheduled starting time.
- 10.8 RRS 29.1 is replaced with: "When at a boat's starting signal any part of her hull, crew or equipment is on the course side of the starting line, the RC shall make note of OCS and record the actual starting time. OCS boats should not attempt to restart. *Individual Recall, code flag* "X," will not be used." This changes RRS 29.1.
- 10.9 Boats that are On Course Side will receive a scoring penalty of five (5) minutes plus the amount of time early. This changes RRS 44.3(c).
- 10.10 In the event a postponement is signaled on the water, the RC shall announce the revised start times on VHF channel 71 before lowering the postponement flag.

#### 11 THE FINISH

11.1 The finish line for All Classes shall be between the hoist of an orange flag on the RC boat and

the course side of mark **R2**, **FI 2.5s** (CBYRA "X").

11.2 The RC may shorten the course at any rounding mark in accordance with RRS 32.

#### 12 TIME LIMIT

The race may be shortened or abandoned in accordance with RRS 32. If at least one boat has finished the RC will report this on VHF and there will be no time limit for the remaining boats in that class if they wish to finish. However, the RC signal boat may not remain on station past 1530 hours. If there is no RC boat at the finish record your own GPS time and note any competitors ahead or behind you. Report your finish time, DNF, or WD to the RC as soon as possible.

#### 13 PENALTY SYSTEM

For Hospice classes & CRCA classes, RRS 44.3 is to be used. This 20% scoring penalty requires that a yellow flag be flown and the Race Committee be notified. No turns are required.

#### 14 PROTESTS AND REQUESTS FOR REDRESS

- 14.1 RRS 61.1(a) is changed to "As a courtesy, the race committee requests (but does not require) that competitors notify them on VHF 71 of their intent to protest another boat."
- 14.2 Protests or requests for redress shall be filed online and are due within one hour after the Race Committee signal boat docks. This changes RRS 62.2.
- 14.3 Notices of protests by the RC or PC will be posted on the Official Notice Board and emailed to inform boats under RRS 61.1(b).
- 14.4 Notice(s) will be posted soon after receipt to inform competitors of hearings in which they are parties or named witnesses.
- **15 SCORING** Boats will be scored in the order of finish (pursuit race) or by TOT corrected elapsed times for PHRF and CRCA classes. PHRF TOT A&B factors will be posted before 1700 Sept. 16.

#### 16 SAFETY REGULATIONS

- 16.1 Except for the **HOSPICE** classes, boats shall check in with the RC Signal Boat prior to their first start of the day by hail of their sail number (or name if no sail number) and an acknowledgement from the RC.
- 16.2 All boats shall carry a VHF radio capable of communicating on VHF channels 9, 13, 16 and 71 the RC channel for Area 2
- 16.3 A boat that retires from a race, or leaves the racing area between races, shall notify the RC at the first reasonable opportunity.
- 16.4 Penalties for breaking SIs 16.1, 16.2, 16.3, or RRS 55 may be less than disqualification if the protest committee so decides

#### 17 RADIO COMMUNICATIONS

- 17.1 RC will communicate with Area 2 competitors on VHF channel 71.
- 17.2 Boats are encouraged to make contact with commercial traffic on VHF channel 13, as required for safety.
- 17.3 Failure to hear a broadcast, the RC's failure to broadcast, or the content of any broadcast shall not be grounds for redress.

#### 18 COMMERCIAL TRAFFIC

- 18.1 A boat may not exercise right of way, cross in proximity to, or interfere with reasonable transit of the race area by commercial traffic. A boat protested under this rule has the burden of proof that she complied with this rule. Boats shall take evasive action well in advance of any potential situations. The U.S. Coast Guard, ship captains, and bay pilots have been encouraged to report any incident they observe.
- 18.2 Boats may not protest other boats for breaking SI 17.1. This changes RRS 60.1.

As skippers and competitors think about their own role in protecting our shorelines and the greater Chesapeake Bay Watershed, they should encourage their crews to avoid single-use plastic bottles and instead bring reusable water bottles to this year's race. Plastic straws, bags, and other single-use plastics should be discouraged aboard all participating boats. Furthermore, RRS 55 prohibits placing trash in the water. Crews are also encouraged to retrieve any trash items seen floating in the vicinity of the racecourse, on the way out, and on the way back. Trash items leftover from crew meals or other provisioning should be disposed of responsibly onshore. Small quantities of biodegradables items accumulated underway can be brought to our composting totes at the shore party for disposal if desired.

# SAILING INSTRUCTIONS

(J/105 and Viper)

#### 1 RULES

Racing will be governed by the *rules* as defined in the current *Racing Rules of Sailing* (RRS) except as modified by the NOR or these Sailing Instructions. These sailing instructions supersede the CBYRA GSI as published in the Green Book.

#### 2 NOTICES TO COMPETITORS

Notices to competitors will be posted on the Official Notice Board located on the Regatta Website <u>https://yachtscoring.com/emenu.cfm?eID=16653.</u>

#### 3 CHANGES TO THE SAILING INSTRUCTIONS

Any change to the Sailing Instructions (SIs) will be posted before 0900 hours on the day of the race, except that any change to the schedule of races will be posted by 2000 hours the day before it will take effect.

#### 4 POSTPONEMENT ASHORE

- 4.1 A Postponement ashore, along with a new intended start time, may be announced on the competitor's VHF channel and posted on the Regatta Website.
- 4.2 A Postponement ashore will end not less than 60 minutes before the new intended start time. This changes RRS Race Signals.

#### 5 SCHEDULE OF RACES: ONE-DESIGNS (J105 and Viper)

- 5.1 At least three (3) races are scheduled. However, fewer races may be sailed depending on conditions and one race will be sufficient to constitute a regatta.
- 5.2 Competitors shall rendezvous at 1000 hours in the vicinity of **R2**, **FI 2.5s** (CBYRA "X"). The racing area is shown in Figure A-1.
- 5.3 Check-in with the Race Committee signal boat is required.
- 5.4 The Warning Signal for the first race is intended to be made at 1100 hours.
- 1.4 No Warning Signal shall be made after 1530 hours.
- 1.5 J/105 racers are encouraged to display their class flag as specified in the CBYRA General SI 4 from the backstay.
- 6 RACING AREA: Chesapeake Bay, off Annapolis. See Figure A-1

#### 7 THE COURSES

7.1 The courses will be windward-leeward, twice around, and the leeward mark or gate will be above the Start/Finish line.

- 7.2 No later than the Warning Signal, the course to be sailed, the approximate heading, and the distance to the first mark will be announced on VHF channel 72.
- 7.3 Rounding marks shall be passed to port.
- 7.4 RC may set a leeward gate. If a leeward gate is placed, boats shall pass between the two marks.
- 7.5 RC may set a weather offset mark. If used, the weather offset mark shall be passed to port.
- 7.6 The leeward mark/gate is not a mark of the course during the first or last leg of the course.
- 7.7 When the first mark of the course is to be a change mark, this will be announced on VHF channel 72.

#### 8 MARKS

- 8.1 Start/Finish mark will be a yellow tetrahedron. All other marks will be orange tomatoes.
- 8.2 The first change mark shall be a yellow tomato. Subsequent change mark will revert to the previous type of mark.

#### 9 THE START

- 9.1 The starting line will be between a staff displaying an orange flag on the RC Signal Boat, and the course side of starting mark on the port end of the line.
- 9.2 The Starting Area is defined as extending 100 yards beyond each end of the starting line and 100 yards behind the starting line and its extensions. Boats shall keep clear of the Starting Area and the first leg of the course until the Signal Boat has sounded its class warning signal.
- 9.3 The intended starting order will be J/105 followed by Viper. Subsequent starts may be in a different order so as to maximize racing for all classes.
- 9.4 The class in sequence will be announced via VHF radio.
- 9.5 Rule 26 of the RRS will be used for starting with the exception that all flags will be verbalized via VHF radio and will not be displayed. There will be a horn blast at each interval, which will take precedence for timing. *This changes RRS 26.*
- 9.6 There may be a break in the starting sequence which will be announced on VHF channel 72. Failure to receive such notification will not be grounds for redress.

#### 10 RECALLS

The Race Committee will attempt to notify boats identified as OCS by announcing their racing numbers on VHF 72. Failure to transmit or receive such notification will not be grounds for redress. This changes RRS 62.

#### 11 CHANGE OF COURSE

To change the next leg of the course, the RC will lay a new mark (or move the finishing line) and remove the original mark as soon as practicable. When in a subsequent change a new mark is replaced, it will be replaced by an original mark.

#### 11 THE FINISH

The finish line shall be between the staff or halyard on the RC Signal Boat displaying a blue flag and the course side of the finishing mark.

#### 12 TIME LIMIT

RRS 35 (Time Limit) is replaced by: "If the first boat in her class does not finish within two (2) hours, the race shall be abandoned. Boats still racing twenty (20) minutes after the first boat in her class finishes, and not subsequently retiring, being penalized or given redress, will be scored TLE (Time Limit Expired, see Scoring) and should proceed to the starting area if another race is scheduled.

#### 13 PENALTY SYSTEM

Appendix V1 shall apply.

#### 14 PROTESTS AND REQUESTS FOR REDRESS

- 14.1 RRS 61.1(a) is changed to "As a courtesy, the race committee requests (but does not require) that competitors notify them on VHF 72 of their intent to protest another boat."
- 14.2 Protests or requests for redress shall be filed online (<u>https://yachtscoring.com/race\_forms.cfm</u>) and are due via email to <u>scc1944.rc@gmail.com</u> within one hour after the Race Committee signal boat docks. This changes RRS 62.2.
- 14.3 Notices of protests by the RC or PC will be posted on the Official Notice Board and emailed to inform boats under RRS 61.1(b).
- 14.4 Notice(s) will be posted soon after receipt to inform competitors of hearings in which they are parties or named witnesses. *Protest hearings are intended to be held virtually; all parties will be emailed with details.*

#### 15 SCORING

- 15.1 RRS Appendix A4, Low Point System, will apply.
- 15.2 One (1) scored race is required to constitute a series.
- 15.3 A boat's series score will be the total of her race scores. This changes RRS A2.
- 15.4 Boats to be scored TLE and not thereafter retiring, being penalized or given redress will be scored points equal to the number of boats finishing within the time limit plus two (2) points by the race committee without a hearing. This changes RRS A4.2 and A5.
- 15.5 One-design scoring will be granted for any class with at least three (3) entries

#### 16 SAFETY REGULATIONS

- 16.1 Boats shall check in with the RC Signal Boat prior to their first start of the day by hail of their sail number (or name if no sail number) and an acknowledgement from the RC.
- 16.2 All boats shall carry a VHF radio capable of communicating on VHF channels 9, 13, 16 and monitor 72, the RC channel for Race Area 3.
- 16.3 A boat that retires from a race, or leaves the racing area between races, shall notify the RC at the first reasonable opportunity.
- 16.4 Penalties for breaking SIs 16.1, 16.2, 16.3, or RRS 55 may be less than disqualification if the protest committee so decides.

#### 17 RADIO COMMUNICATIONS

- 17.1 RC will communicate with competitors on VHF channel 72.
- 17.2 Boats are encouraged to make contact with commercial traffic on VHF channel 13, as required for safety.
- 17.3 Failure to hear a broadcast, the RC's failure to broadcast, or the content of any broadcast shall not be grounds for redress.

#### 18 COMMERCIAL TRAFFIC

- 18.1 A boat may not exercise right of way, cross in proximity to, or interfere with reasonable transit of the race area by commercial traffic. A boat protested under this rule has the burden of proof that she complied with this rule. Boats shall take evasive action well in advance of any potential situations. The U.S. Coast Guard, ship captains, and bay pilots have been encouraged to report any incident they observe.
- 18.2 Boats may not protest other boats for breaking SI 18.1. This changes RRS 60.1.
- 18.3 The RC or PC may protest under SI 18.1, based on information received from any source. There is no time limit for protests filed under SI 18.1. This changes RRS 60.2, RRS 60.3, and RRS 61.3.

- 18.4 RRS 42.3 (Propulsion Exceptions) is changed by adding: "(j) A boat that is without way in a ship channel may use any means of propulsion to clear the channel at the approach of commercial traffic provided that, when becoming clear of the commercial traffic, the boat has not improved their position as a result of this action. A boat claiming this exception shall report the incident in writing to the protest committee within the protest time limit, with all the facts necessary to substantiate the boat's speed and change of position during the incident."
- 18.5 RRS 62.1 (Redress) is changed by adding: "(e) clearing a ship channel in compliance with SI 18.4."

#### 19 PRIZES & SHORE PARTY

- 19.1 Prizes in each class will be given to 1<sup>st</sup>, 2<sup>nd</sup>, and 3<sup>rd</sup> place finishers.
- 19.2 Sponsored trophies are underwritten by multi-year pledges from corporate or individual sponsors.
  - Sajak Family Foundation Trophy awarded for the best performance in Cruising One
    Design
  - Geri Manning Memorial Trophy for the racing crew raising the most money
  - Donnybrook-Brendan Trophy awarded to the team with the highest percentage of youth crew participation
  - The Van Metre Family Trophy awarded to the best performance in entire Hospice Cup Fleet
  - **The Hospice Cup** is the top honor awarded for best three-year performance; it qualifies the winner to compete in the annual Hospice Regattas National Championship against representatives of the many other hospice regattas sailed nationwide, each event patterned on this original hospice regatta.
  - Annapolis Triple Crown Charity Trophy This trophy is a partnership between the Leukemia Cup, CRAB Regatta and Hospice Cup. Racers must participate in each of the three charity regattas AND fundraise. The calculation for the winner shall be the order of finish in each race and the amount of funds raised for each race. The amount of funds raised shall be given a higher multiplier (1.5) in the calculations. - 19.3 **The post-race shore** party and award pickup will be at Horn Point Marina from 1730 to 2100. Complimentary oysters, appetizers, and cake will be first come first served. Christian Douglas from burgers. will also be onsite making smash burgers. Proceeds from the sale of the day's burgers go directly to Hospice Cup to support its partner charities. Donations and tips are strongly encouraged at the bars.


