NOTICE OF RACE

1. RULES

- 1.1 The regatta will be governed by the rules as defined in The Racing Rules of Sailing; the current IRC regulations as administered by US-IRC; the current PHRF regulations as administered by the YRA of Long Island Sound (YRALIS); the Class rules of any fleet racing as a one design division (except as any of these are altered by the Notice of Race or the Sailing Instructions); the Notice of Race; and the Sailing Instructions, **INCLUDING THE NAVIGATOR CLASS SUPPLEMENTAL SAILING INSTRUCTIONS**. Level and one-design class divisions will be responsible for administering their class rules.
- 1.2 Boats sailing in handicap divisions shall observe the Minimum Equipment Recommendations of the YRALIS, Race Category C. Boats sailing in one-design divisions shall observe the regulations of their respective classes.

2. ELIGIBILITY & ENTRY

- 2.1 This regatta is open to PHRF (210 and faster), IRC and offshore one-designs having a minimum of five entrants.
- 2.2 Boats must be enrolled in the YRALIS or other USS association.
- 2.3 Eligible boats may enter online via <http://www.riversideyc.org> (preferred), or by completing the attached form and sending it, together with the required fee to Race Committee, Riverside Yacht Club, 102 Club Road, Riverside CT 06878.

3. FEES

The entry fee is \$140 if registering for both spring and fall series; \$80

if registering for only one.

4. SCHEDULE (amended April 28, 2009)

The first warning signal for the first start of the day will be at **1055**. The Race Committee may hold up to four races on Saturday and three on Sunday. The Navigator division(s) will sail one race per day.

5. SAILING INSTRUCTIONS

6. VENUE

All divisions will rendezvous approximately 1.5 miles South of Great Captain Island.

7. COURSES

Courses will be described in the Sailing Instructions.

8. MOORINGS/DOCKAGE

9. PRIZES

- 9.1 Prizes will be awarded to 1st, 2nd, and 3rd place for each division for each Series. Prizes will be awarded at the conclusion of racing for each Series on Sunday at Indian Harbor Yacht Club in the spring and at Riverside Yacht Club in the fall.
- 9.2 The Greenwich Cup will be awarded at the conclusion of the Fall Series to a boat which competes in both the Spring and Fall Series and in the opinion of the Race Committee has demonstrated the most outstanding performance.
- 9.3 The overall winners for each division in the Combined Spring and Fall Series shall be engraved on the permanent trophies of the Indian Harbor Yacht Club and Riverside Yacht Club, and their prizes presented at each Club's Annual Awards Dinner.
