NOTICE OF RACE

1 ORGANIZING AUTHORITY

The Organizing Authority (OA) is the Farr 40 Class Association in conjunction with the Sailing Club "Val" Šibenik Croatia (SC "Val").

2 HEADQUARTERS

The Event Headquarters will be: D Marin, Marina Mandalina, Obala Jerka Šižgorića 1, 22 000 Šibenik, Croatia.

3 RULES

- **3.1** This regatta will be governed by the rules as defined in The Racing Rules of Sailing (RRS) and the Farr 40 Class Rules.
- **3.2** Yachts shall comply with the 2016 2017 World Sailing Offshore Special Regulations, Category 4 (except that 5.01.1 (a) shall not apply for this event) and Appendix 3 of the Farr 40 Class Rules. In the event of conflict, designer and manufacturers original standards shall prevail.
- **3.3** Please refer to Class Rule 30 which states "Except on a beat to windward, a boat's crew may pull in any sail any number of times. This changes RRS 42.3 (c).
- **3.4** Delete the first and second sentences of RRS 44.1 and substitute the following: A boat may take a One-Turn Penalty, consisting of one tack and one gybe, when she may have broken a rule of Part 2, Rule 31, or Rule 42 while racing. However, if a boat may have broken a rule of Part 2 within the zone of a mark other than a starting mark, the penalty that may be taken is a Two-Turns Penalty. This changes RRS 44.1.
- **3.5** When leaving the dock, boats shall carry a minimum of 1.5 liters of drinkable liquid up to a maximum of 4 liters, per person per day. This liquid is included in the restrictions for moveable ballast in RRS 51, except when being consumed by a crew member.
- **3.6** In RRS 55 add the following: Bilge water, bodily fluids and biodegradable sail stops are not trash under this rule. A breach of this rule, pertaining to non-biodegradable sail stops only, is not open to protest by boats and may only be protested by the Race Committee or Protest Committee. This changes RRS 55.



















NOTICE OF RACE

- **3.7** In RRS 61.1(a), after the second sentence, add the following words: "The red flag shall have the minimum dimensions of 45 cm x 45 cm and shall be displayed vertically from the backstay, below the backstay flag." This changes RRS 61.1.
- **3.8** Video, electronic data and/or photographs taken from any source shall not be used as evidence at a protest hearing or request for redress, except that Race Committee voice recordings are permitted to be used as evidence. This changes RRS 63.6.
- **3.9** If there is a conflict between the NOR and the SI, the SI shall prevail. Neither the NOR nor the SI shall change nor alter any Class Rules. This changes RRS 63.7.
- **3.10** Due to safety concerns it is not required to carry fuel for the stove onboard.

4 ELIGIBILITY

The regatta is open to all Farr 40 Class yachts as defined by the Class Rules. Owners, charterers and Substitute helmsmen shall be current members of the Farr 40 Class Association and approved by the Farr 40 Class Eligibility Review Committee.

5 ENTRY AND REGISTRATION

- **5.1** Eligible boats may enter and pay the US\$1,750 entry fee on line at http://www.yachtscoring.com/emenu.cfm?eID=2707
- **5.2** The entry form shall be completed and entry fee shall be submitted to http://www.yachtscoring.com/emenu.cfm?eID=2707 no later than May 4, 2016. Late entries may be accepted however an additional fee of \$100 US will be due for entries received after that date.
- **5.3** Crew lists and World Sailing Sailor User IDs for all crew shall be submitted to http://www.yachtscoring.com/emenu.cfm?eID=2707 no later than May 10, 2016. Designation of alternate, relief or substitute helmsmen and a copy of a valid 2016 One Design Certificate shall be submitted to Stagg Yachts no later than May 17, 2016.

- **5.4** Registration shall be completed with the OA as described below. Sail declarations may be made on site during registration. To be entered a competitor shall have completed the following no later than 17:00 May 17, 2016.
 - (a) Registered with the OA, including payment of all fees;
 - (b) Entry Form and 2016 One Design Certificate on file with the OA;
 - (c) Owner, Charterer and Substitute Helmsmen Class Membership Dues for 2016 paid and on file with Stagg Yachts
 - (d) Liability waivers signed and on file with the OA;
 - (e) Sail Declaration form on file with the OA;
 - (f) Crew classification declared and verified at

http://www.yachtscoring.com/emenu.cfm?eID=2707, and on file with the OA;

- **(g)** All owners, tacticians and boat captains shall have signed and submitted to the OA Appendix 10 stating they have read the class rules, that their boat fully complies with the Class Rules and that they will abide by said Class Rules while racing.
- **5.5** Skipper and crew weigh-in shall be completed no later than 1030 May 18, 2016.

6 SCHEDULE

- 6.1 May 16 09:00 17:00, Registration and Weigh-in Marina Mandalina
 - May 17 09:00 17:00, Registration and Weigh-in Marina Mandalina
 - May 17 12:30, Practice starts followed by practice race
 - May 17 17:30, Mandatory Tactician's Briefing Marina Mandalina
 - May 18 08:00, Weigh-in Marina Mandalina
 - May 18 1st Race Day, Initial Warning 12:30
 - May 19 2nd Race Day, Initial Warning 12:30
 - May 20 3rd Race Day, Initial Warning 12:30
 - May 21 4th Race Day, Initial Warning 12:30
- **6.2** The race committee intends to conduct as many races as practicable, up to a maximum of 11 races for the series. No Warning Signal will be made after 1500 on the last scheduled day of racing, except as a consequence of a general recall.
- **6.3** After consultation with a noncompeting Class Representative, the Race Committee may modify the above program according to prevailing weather conditions and/or other unforeseen circumstances.

7 MEASUREMENT AND INSPECTION

- **7.1** Inspection will take place on May 16 and May 17. Each yacht shall provide a minimum of 1 person to facilitate inspection.
- **7.2** Crew will be weighed on the official scales at registration.
- **7.3** All sails must be buttoned and declared as per Class Rules. Random measurement will be conducted. The Class Secretary shall advise on site which sails will be measured.
- **7.4** Random yacht and equipment inspections may be conducted prior to, between races and after racing each day to check for compliance with Class Rules, the NOR and the 2016 2017 World Sailing Offshore Special Regulations, Category 4, except as modified by this NOR 3.2

8 EVENT ADVERTISING

- **8.1** Advertising is permitted in accordance with World Sailing Regulation 20.
- **8.2** Each yacht may be required to display event advertising on their bow, backstay and boom, and may be strongly urged to fly the forestay battle flag while docked.

9 SAILING INSTRUCTIONS

Sailing Instructions will be available at registration and at www.farr40.org and http://www.yachtscoring.com/emenu.cfm?eID=2707 no later than 72 hours prior to the first race.

10 COURSES AND RACING AREA

Courses will be defined in the Sailing Instructions. Races will be held in the Middle Adriatic - water of Island Zlarin, Šibenik bay. Attachment A shows the location of the courses.

11 PENALTIES

The penalty, if any, for any infringement of the rules (including the Class Rules and World Sailing Offshore Special Regulations, Category 4) other than rules of Part 2 will be at the sole discretion of the Protest Committee in consultation with the Class Representative, and may be other than disqualification. This changes RRS 64.1.



















NOTICE OF RACE

12 SCORING

- **12.1** Each yacht's score shall be the sum of all of her race scores with no discard, 11 races are scheduled.
- **12.2** Four races are required to be completed to constitute a series.
- **12.3** On the last day of racing the Race Committee shall endeavor to broadcast updated scoring on VHF 77 after the first race of the day and subsequent races prior to the final race of the series.

13 PRIZES

13.1 Trophies for the events will be awarded for first through third place overall, first through third Corinthian boats, the top overall boat each day with additional trophies at the OA's discretion.

14 DOCKAGE

- **14.1** Boats may start arriving at Marina Mandalina after 09:00 hours on May 16 and all boats shall be docked at their assigned dock from 18:00 hours May 16 until the end of the event. They shall remain at Marina Mandalina at all times when not practicing or test sailing, racing, or transiting to and from the racecourse. There is no charge for dockage.
- **14.2** Should a dock at Marina Mandalina be required for a longer period, entrants shall contact the Marina Mandalina directly. Extended bookings will be chargeable at the current Marina Mandalina rates. Early booking is recommended. Telephone bookings must be confirmed by fax, email or post. Marina Mandalina Marina captain Marko Erceg merceg@d-marin.com.
- **14.3** Parking for Support Trailers and Vans must be arranged with Marina Mandalina in advance.

15 SUPPORT BOATS

- **15.1** Competitors' attention is drawn to the applicable Class Rules and Interpretations.
- **15.2** Support and Media boats shall register with the OA and shall display clear identification provided at registration.
- 15.3 Dockage for support boats must be arranged with Marina Mandalina in advance.

15.4 While racing, the use of unmanned aerial vehicles (drones) by any team or persons associated with, supporting or employed by a team, is prohibited within the area described in Class Rule Interpretation 63 and extended vertically. A breach of this rule is not open to protest by boats and may only be protested by the Race Committee, Protest Committee, or Organizing Authority.

16 HAUL-OUT RESTRICTIONS

Yachts may be hauled out only with the prior written permission of the Protest Committee, and under such terms as they may decide. Normally, the Protest Committee shall grant such permission only if necessary to repair damage. While hauled out, bottoms and foils shall not be sanded, polished, washed or otherwise worked on exceptin the area of repair as permitted by the Protest Committee. Hulls and appendages may be cleaned in the water.

17 MEDIA AND IMAGE RIGHTS WAIVER

17.1 By entering this regatta, the owner (or charterer) and crew members on competing yachts grant at no cost the absolute right and permission to use their names, voices, images, likenesses, and biographical material, as well as representations of their yacht in any media (including television, print and internet), to the OA, the Farr 40 Management Group, Stagg Yachts, the Farr 40 Executive Committee, D-Marin Šibenik, and other sponsors.

17.2 The Organizing Authority, the Farr 40 Management Group, Stagg Yachts, the Farr 40 Executive Committee, D-Marin Šibenik and other sponsors shall not use the names, voices, images, likenesses or biographical material of an owner (charterer) or crew member in a way that constitutes an endorsement of products unless the competitor or crew member is other wise engaged by main sponsor or affiliated companies to endorse its products or otherwise gives his/her prior written consent to such use.

17.3 Owners (charterers) and crew members shall acknowledge and accept the granting of media rights referred to in this paragraph 17 by signing the Declaration contained on the Appendix 5 Crew Declaration Form.

18 DISCLAIMER

- **18.1** All those taking part in the race do so at their own risk and responsibility. The owner (charterer) and each crew member:
 - (a) acknowledges and accepts the risks (including the risk of harm to persons and property and the risks associated with the perils of the sea and the seaworthiness of any boat) associated with participation in this regatta and waives all rights against and releases, the Organizing Authority, the Farr 40 Management Group, Stagg Yachts, the Farr 40 Executive Committee, D-Marin Šibenik, and their respective officers, employees, volunteers and members in respect of any loss of life or injury to persons, or loss of or damage to property, suffered in connection there with;
 - **(b)** acknowledges that participation in this regatta by him or her is on the basis that participation is entirely at his or her risk and responsibility and that, the Organizing Authority, the Farr 40 Management Group, Stagg Yachts, the Farr 40 Executive Committee, D-Marin Šibenik, and their respective officers, employees, volunteers and members are not responsible for any boat or its crew;
 - **(c)** acknowledges and agrees that this form is governed by the laws of the United States and that any liability for harm to persons that results from breach of an express or implied warranty that this regatta and all services relating thereto will be conducted or rendered with reasonable care and skill is excluded.
- **18.2** Specific attention is drawn to RRS Fundamental Rule 4, which states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone". All competitors shall acknowledge this by signing the Declaration contained on the Appendix 5 Crew Declaration Form.



















NOTICE OF RACE

19 INSURANCE

- **19.1** The safety of a boat and her entire management shall be the sole inescapable responsibility of the owner/owners' representative. It is the responsibility of the owner to provide insurance for the yacht covering eventual damage to persons or property.
- **19.2** The boat is required to hold adequate insurance including third-party insurance of minimum coverage of \$1,000,000 US. It is the owner or owners' representative's sole and inescapable responsibility to ensure that the insurance is in place and is adequate prior to participating in this event.

20 COMMERCIAL SHIPPING

- **20.1** Yachts shall not interfere with the Commercial or Defense shipping of the Port.
- **20.2** Boats found to have interfered with commercial shipping may be subject to action by the Race Committee in accordance with RRS 60.2.
