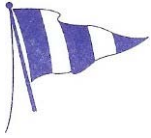

NOTICE OF REGATTA

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing 2009-2012*, the current IRC Rules, the current PHRF Regulations as administered by the YRA of LIS and Level or One-Design Class rules
- 1.2 Boats shall observe the Minimum Equipment Recommendations of YRA of LIS, Race Category C.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Part 5, Section B is changed to provide for arbitration of protests of Part 2 rules.

2 ENTRIES

- 2.1 Eligible boats may enter by registering on line at Yacht Scoring: www.yachtscoring.com or on approved entry forms received by the Larchmont Yacht Club front desk not later than 1700, Wednesday, July 7, 2010
- 2.2 The Entry Fee is \$100.00. Classic Boats which will sailing only Saturday July 10, the entry fee is \$75.00
- 2.3 There will be IRC, Level, Classic, One Design and PHRF divisions. At the discretion of the race committee separate divisions for Level and One-Design may be assigned. Divisions may be subdivided into classes.
- 2.3(a) For those classes not sailing Level or One Design, entries must be accompanied by a valid PHRF or IRC rating certificate. PHRF certificates from other areas will be adjusted to conform to the YRA of LIS. IRC certificates do not need to be endorsed.

3 SAILING INSTRUCTIONS

- 3.1 Sailing Instructions will be available at least one week before the regatta on the internet at: www.larchmontyc.org and www.yachtscoring.com or at the Larchmont Yacht Club front desk or the Hospitality Desk on the day of the event. Sailing instructions may also be available on the first day of racing prior to the first warning signal of the day from the committee boat.
- 3.2 Scratch Sheets will be available at the front desk after 1800 Friday, July 9, at the Hospitality Desk during the event and, and from the committee boat prior to the first warning signal of the day or on line at Regatta Manager.

4 COURSES, RACING AREA AND RACES

- 4.1 The racing area will be south of Milton Point.
- 4.2 The courses will be as described in the Sailing Instructions.
- 4.3 The warning for the first division will be at 1055 each day.

5 SCORING

- 5.1 One completed race constitutes a series.
- 5.2 If fewer than five races are completed, a boat's series score will be the total of her race scores. If five or more races are completed a boat's series score will be the total of her race scores excluding her worst score subject to rule 90.3 (b).
- 5.3 For PHRF time allowances will be computed using Time on Distance.
For IRC the boats rating allowance will be applied as a factor of the elapsed time.

6 PRIZES

Series prizes for First, Second and Third places in each division will be awarded on Sunday, July 18 after racing on the front lawn of the Larchmont Yacht Club.

7 GUEST MOORINGS AND CLUB PRIVILEGES

- 7.1 Guest moorings will be available on a first come basis at no charge. Reservations require. Please contact the Waterfront Director, Lincoln White, at 914-468-7742 or email moorings@larchmontyc.org for reservations.
- 7.2 The privileges of the Club for Race Week will be extended to owners and crews.

NOTICE OF RACE

1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing 2009-2012*.
- 1.2 Part 5, Section B is changed to provide for arbitration of protests of Part 2 rules.

2 CLASSES

- 2.1 The regatta is open to the following one-design classes: Etchells, I.O.D, Shields, Sonar, S Boats, RK6s and 505s. To qualify as a class for this regatta, 3 valid entries must be received for that class prior to 1800, Wednesday, July 7.
- 2.2 A class may elect to race on one weekend instead of the two that are scheduled. On days when a class elects not to race, boats in that class will not get a start, nor will they be scored, provided that the race committee has been previously informed of such class decision.

3 ENTRIES

- 3.1 Eligible boats may enter by registering on approved entry forms received at the Larchmont Yacht Club front desk not later than 1200 Friday, July, 9, 2010 OR online at: www.yachtscoring.com or www.larchmontyc.org
- 3.2 The entry fee is \$100.00 per boat. For classes electing to race one weekend the entry fee is \$75.00.
- 3.3 All entries not submitted on line, shall be mailed to the Larchmont Yacht Club, 1 Woodbine Ave., Larchmont, NY 10538. Telephone: 914-834-2440. Faxed entries will be accepted only with a valid signature for credit card authorization. Fax: 914-468-7751. All entries must be signed by the owner or master. Credit card authorizations must be legible and signed by the card holder.

4 SAILING INSTRUCTIONS

The 2010 YRALIS Mid-Sound One-Design Sailing Instructions will apply. Amendments, if any, to these sailing instructions will be available at the front desk of the Larchmont Yacht Club no later than Wednesday, July 7th or on the website at: www.yachtscoring.com or www.larchmontyc.org.

5 COURSES AND RACES

- 5.1 The first warning signal will be at **1225** each day.
- 5.2 The courses will be as described in the 2010 Mid-Sound Sailing Instructions.
- 5.3 The race committee intends to run multiple races each day.

6 SCORING

- 6.1 The Low-Point Scoring System of App. A4 will apply. One completed race constitutes a series.
- 6.2 If fewer than five races are completed a boat's series score will be the total of her race scores. If five or more races are completed, a boat's series score will be the total of her race scores excluding her worst score subject to rule 90.3 (b).

7 PRIZES

- 7.1 Series prizes will be awarded on Sunday, July 18, after racing, on the front lawn of the Larchmont Yacht Club.
- 7.2 Series prizes will be awarded for classes that qualify under section 2.
First place for all classes with three or more competitors.
Second place for all classes with four or more competitors.
Third place for classes with five or more competitors.

8 GUEST MOORINGS, USE OF HOISTS AND PRIVILEGES

- 8.1 Guest moorings will be available on a first come basis. Please contact the Waterfront Director, Lincoln White or email moorings@larchmontyc.org
- 8.2 The Club's hoists will be available for launching and taking out visiting boats. Dry sailed boats may be parked at the owners' risk on trailers in the boat yard from July 9 to July 20. Please contact the Waterfront Director at the Larchmont Yacht Club for reservations and hoist use.
