- 1.2 Boats shall observe the current Minimum Equipment Recommendations of YRA of LIS, Race Category C. However, section 2, Structural Features, does not apply to boats not designed and equipped with pulpits, stanchions, lifelines or self-bailing cockpits.
- 1.3 Each boat shall carry a radio capable of transmitting and receiving on VHF channel 73.
- 1.4 Appendix T will apply as changed below:  
At the end of T4, Arbitration Meeting Outcomes, add: (c) If a protest is not withdrawn after arbitration, the arbitrator will not be a member of the jury that hears that protest but will be permitted to observe the testimony presented and offer evidence. This changes rule 63.3(a).

#### **2 ENTRIES**

- 2.1 Eligible boats may enter by submitting an entry online at [www.yachtscoring.com](http://www.yachtscoring.com) Entries must be submitted no later than 1700, Wednesday, July 11, 2018
- 2.2 The entry fee is \$75.00, payable online.
- 2.3 At the discretion of the race committee, separate divisions may be assigned. Divisions may be divided into classes.
- 2.4 2018 CRF MkII rating certificate showing seconds per mile shall be submitted by the entry deadline. To apply for a 2018 CRF MkII rating certificate, go to [www.classicratingformula.com](http://www.classicratingformula.com) .

#### **2 ELIGIBILITY AND ENTRIES**

- 2.1 The regatta is open to IRC, PHRF and Offshore One Design Racer-Cruisers and Non-Spinnaker Boats. At the discretion of the race committee, some divisions may be divided into separate classes.
- 2.2 Eligible boats may enter by registering online at Yacht Scoring:

- 2.4 For those classes not sailing One-Design, entries shall be accompanied by a valid PHRF or IRC rating certificate. PHRF certificates from other areas will be adjusted to conform to the YRA of LIS.

#### **3 SCHEDULE, COURSES AND RACING AREA**

- 3.1 The racing area will be in the waters off Larchmont Harbor.
- 3.2 The first warning will be at 1255 each day.

5.3 For PHRF, time allowances will be computed using Time on Time. For IRC the boat's rating allowance will be applied as a factor of the elapsed time.

## **6 PRIZES**

- 6.1 Series prizes for first, second and third places in each division will be awarded on Sunday, July 22 following the completion of racing on the front lawn of the Larchmont Yacht Club.  
6.3 Perpetual trophies will be awarded at the discretion of the race committee, fastest elapsed time in the Execution Rocks Race, and fastest corrected time in the Execution Rocks Race.  
6.4 A boat which sets a new elapsed time course record in the Execution Rocks Race will receive a case of Mt. Gay Rum. The current elapsed time record is 39 minutes 51 seconds, set by Christopher Dragon on 23 July 2017.  
6.5 This regatta is a qualifying event for the YRA Youth Challenge Cup, the Gitano, Sappho, Competitors, Kings Point and Allegra Knapp Mertz awards.

#### 2 ELIGIBILITY

2.1 The regatta is open to the following one-design classes: Viper 640, Etchells, J/70, IOD, Shields, S-Boat or any other one-design class that qualifies. To qualify as a class for this regatta, three valid entries must be received for that class prior to 1800, Wednesday, July 11.

2.2 If a class elects to race on a single weekend, the Class Fleet Captain shall notify the race committee no later than Wednesday, July 11. On days when that class elects not to race, boats in that class will not be given a start, nor will they be scored.

### NOTICE OF RACE

#### 1 RULES

- 1.1 The regatta will be governed by the *rules* as defined in *The Racing Rules of Sailing*.
- 1.2 Coast Guard-approved personal flotation must be worn by skipper and crew at all times while on the water, except briefly while changing or adjusting clothing or personal equipment. This changes rule 40 and the preamble to the Part 4 rules.
- 1.3 Appendix U, Audible-Signal Racing System will apply as described in the sailing instructions.
- 1.4 Rule V1, Penalty at the Time of an Incident, will apply.

#### 2 ENTRY AND FEE

- 2.1 The series is open to any Ideal 18 with bottom paint.
- 2.2 There are three regattas within this series, a one-day regatta on June 16, a two-day regatta during Larchmont Race Week on July 14 and 15, and a one-day regatta on August 18. To qualify for the series prizes, a skipper must sail in the Larchmont Race Week regatta plus one of the other one-day regattas.
- 2.3 Eligible boats shall enter online by 1200 the Friday before the regatta. For races on June 16 and August 18, boats must enter on [https://larchmontyachtclub.formstack.com/forms/2017\\_ideal18\\_summerseries\\_copy](https://larchmontyachtclub.formstack.com/forms/2017_ideal18_summerseries_copy). For boats sailing during Larchmont Race Week (July 14 and 15) boats must enter at: [https://yachtscoring.com/event\\_registration\\_email.cfm?eid=4660](https://yachtscoring.com/event_registration_email.cfm?eid=4660)
- 2.4 The entry fees are: \$150.00 for all four days, \$50 for either one-day regatta on June 16 or August 18, and \$85 for the two-day regatta on July 14 and 15.

#### 3 BOATS

- 3.1 All skippers shall equip their boat with a portable VHF.
- 3.2 A limited number of boats may be available for use by non-LYC sailors. To request a boat, please contact Hobie Ponting, Assistant Sailing Director at [hobie@larchmontyc.org](mailto:hobie@larchmontyc.org).
  - a) All non-LYC sailors using LYC boats will be required to provide a damage deposit of \$1000.00. A valid credit card must be presented prior to the competitors' meeting.
  - b) A maximum of \$1000.00 will be charged for each incident that results in damage or loss of equipment. No charge will be made without prior notification. If two boats are involved, the damage will be allocated: to the skipper losing the protest, to both skippers if the right-of-way boat is found in violation of rule 14, or to the skipper of the damaged boat(s) if no protest is filed.



c) Borrowed boats will be assigned by lottery. If another club has loaned boats to LYC for this event, members of that club shall have first draw against his/her club's boats.

8.1 One completed race in each of the three regattas will constitute a regatta.

8.2 Scoring for each individual regatta will be high-point. If fewer than 6 races are completed a boat's series score will be the total of her race scores. If 6 or more races are completed a boat's series score will be the total of her race scores excluding her worst score.

8.3 Scoring for the series will include the results from the Larchmont Race Week two-day regatta plus the results for the skipper's better day of the one-day regattas. The series score for each boat will be a percentage calculated as follows: divide the sum of her race scores by the sum of the points she would have scored if she had placed first in every race in which she competed; multiply the result by 100, excluding any races thrown out in NoR 8.2. The qualifying boat with the highest series score is the winner, and others are ranked accordingly

- 9.1 Prizes for the series will be awarded to the top three finishers after racing on August 16..
