1 RULES

1.1 The Regatta will be governed by the rules as defined in The Racing Rules of Sailing.

2 ELIGIBILITY AND ENTRY

- 2.1 The Morgan Invasion fleets are open to all sailboats that were built or designed by Charley Morgan.
- 2.2 The Multi-Hull fleets are open to one-design multihull sailboats and all multi-hull sailboats with a valid West Florida PHRF certificate.
- 2.3 The PHRF fleets are open to all sailboats with a valid West Florida PHRF certificate
- 2.4 The Just-for-fun fleet is open to all sailing vessels 18 feet in length or larger. No PHRF certificate required.
- 2.5 Boats may enter by using one of the following methods:
 - (a) Complete the online form on the TBHC website at http://TampaBayHospiceCup.com
 - (b) Complete the attached form and send it, together with the required fee, to the address on the form.
 - (c) Deliver an entry form and fee to the registration desk by 1900 on April 20, 2018

3 FEES

- 3.1 The registration fee for this event is \$60.00.
- 3.2 US Sailing members receive a \$5 discount.

5 SAILING INSTRUCTIONS

5.1 The Sailing Instructions will be available at registration and may also be available on the DIYC web site (diyc.org) prior to the event.

6 THE COURSES

- 6.1 Distance courses with a pursuit start are planned for the Morgan Invasion fleets, PHRF Spin, Non-Spin, Racer/Cruiser, and Multi-hull fleets.
- 6.2 A casual fixed mark course is planned for the Just-for-fun fleet

7 SCORING

- 7.1 Distance courses will be scored using time on distance with WFPHRF RLC rating using a pursuit based start.
- 7.2 Scoring for the Just-for-Fun fleet will be performed by the race committee and described in the competitor's meeting.

8 RADIO COMMUNICATION

- 8.1 Boats shall have a VHF radio capable of receiving transmissions on channel 72.
- 8.2 Except in an emergency, a boat shall neither make radio transmissions while racing nor receiving radio communications not available to all boats. This restriction applies to mobile telephones and other communication devices.

9 PRIZES

- 9.1 Prizes will be awarded April 21, 2018
- 9.2 All fleets will receive prizes based on the number of entries.

10 DISCLAIMER OF LIABILITY

10.1 Competitors participate in the regatta entirely at their own risk, see rule 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.
