

**SAILING INSTRUCTIONS  
2019 RAFT PARTY RACE  
LAKESHORE YACHT CLUB  
JUNE 29<sup>TH</sup> 2019**

**RULES:**

- 1.1 The regatta will be governed by the 'rules' as defined in the Racing Rules of Sailing (RRS).
- 1.2 The prescriptions of Sail Canada will apply and will be posted on the Official Notice Board or visit [http://www.sailing.ca/files/RRS\\_2017\\_2020\\_Sail\\_Canada\\_Prescription\\_Final\\_EN.pdf](http://www.sailing.ca/files/RRS_2017_2020_Sail_Canada_Prescription_Final_EN.pdf)
- 1.3 The class rules for the handicap classes are PHRF Lake Ontario (PHRF-LO) for PHRF fleets as modified by the designated Handicapper.
- 1.4 The class rules of participating classes will apply.
- 1.5 For protests involving an infringement of a rule of Part 2 of the RRS, an arbitration hearing may be held in accordance with RRS Appendix T. The arbitrator may attend a full hearing.
- 1.6 For all classes RRS 44.1 is changed so that the Two-Turns Penalty is replaced by the One-Turn Penalty for incidents outside the Zone.

**NOTICE TO COMPETITORS:**

- 2.1 All notices shall be posted electronically to [www.yachtscoring.com](http://www.yachtscoring.com)
- 2.2 All notices will be posted on the official notice board located on the patio.

**CHANGES TO SAILING INSTRUCTIONS:**

- 3.1 All changes to sailing instructions shall be posted 10:00 on the day of the event.

**SIGNALS MADE ASHORE:**

- 4.1 All signals made ashore shall be displayed at the Flag Pole located on the patio.

**RACE SCHEDULE:**

- 5.1 First warning signal will be 14:00
- 5.2 No starting sequence will commence after 16:00
- 5.3 Skippers Meeting will be held 19:00 on Friday June 28<sup>th</sup> 2019 at LSYC Great Room.

**COURSE:**

- 5.1 The course will be a multiple point to point race (specific course to be posted by June 28<sup>th</sup> 2019 at 18:00. Please see **Appendix A: Eligible Marks** – for waypoint locations. Please see **Appendix B: Planned Course**.
- 5.2 All rounding marks will be taken to Port side.

**START:**

- 6.2 First Warning will be June 29<sup>th</sup> 2019 at 14:00
- 6.3 The Start line will be between RC "Lakeshore Lady" and LSYC MARK 0.
- 6.4 All Starts shall be rolling with 1 minute in between each division warning signal.
- 6.5 Division Splits shall be displayed by June 28<sup>th</sup> 2019 at 18:00 on the event website.
- 6.6 Each boat shall check in with Race Committee no later than 15 minutes prior to the First Warning.
- 6.7 If any part of a boat's hull, crew or equipment is course side of the starting line during or following the starting signal, the race committee may announce this on VHF Channel 74. Failure to

do so is not grounds for redress. This changes RRS 62.1.

6.8 Individual recalls will comply with RRS 29.1. The Race Committee may announce via VHF Channel 74 the sail number or boat name of each premature starter. The failure to announce or the order in which boats are announced shall not be grounds for redress. This changes RRS 62.1.

**FINISH:**

7.1 All boats shall finish through the original Start line with RC to Port and Start/Finish Mark to Starboard.

7.2 All boats shall record their own finish time according to GPS Time.

**TIME LIMITS:**

8.1 A time limit of 45 minutes after the first boat to finish in each class will apply. Boats failing to finish by the time limit for their class will be scored DNF. This changes RRS 35 and A5

**PENALTY SYSTEM:**

9.1 A boat that has taken a penalty or retired under RRS 44.1 shall notify the race committee after she has finished or retired.

**PROTESTS AND REQUESTS FOR REDRESS INCLUDING ARBITRATION:**

10.1 Boats are requested to notify the Race Committee, by VHF radio immediately after finishing or withdrawing, of their intention to protest in that race, naming the boat(s) protested.

10.2 Protest forms are available at the Jury Desk as indicated on the Official Notice Board.

10.3 Protests shall be lodged in writing at the Jury Desk within 90 minutes of: a) the time of the last boat to finish the last race of the day on the protesting boat's course, or b) expiry of the time limit if that terminated the last race of day, or c) abandonment of racing for the day on the protesting boat's course, whichever is applicable.

10.4 Notice of protests to be heard will be posted on the Official Notice Board within 30 minutes of the End of protest time. This serves as notice as required by RRS 63.2.

10.5 Protest hearings will be held as soon as possible after being posted.

10.6 Breach of class or handicap rules will be allowed as grounds for protest provided the protestor submits an official copy of said one-design or handicap rules to the Protest Committee when filing the protest.

**SCORING:**

11.1 The Regatta will be scored as a single series with one race required to be completed to constitute a series. All races in the Regatta to count.

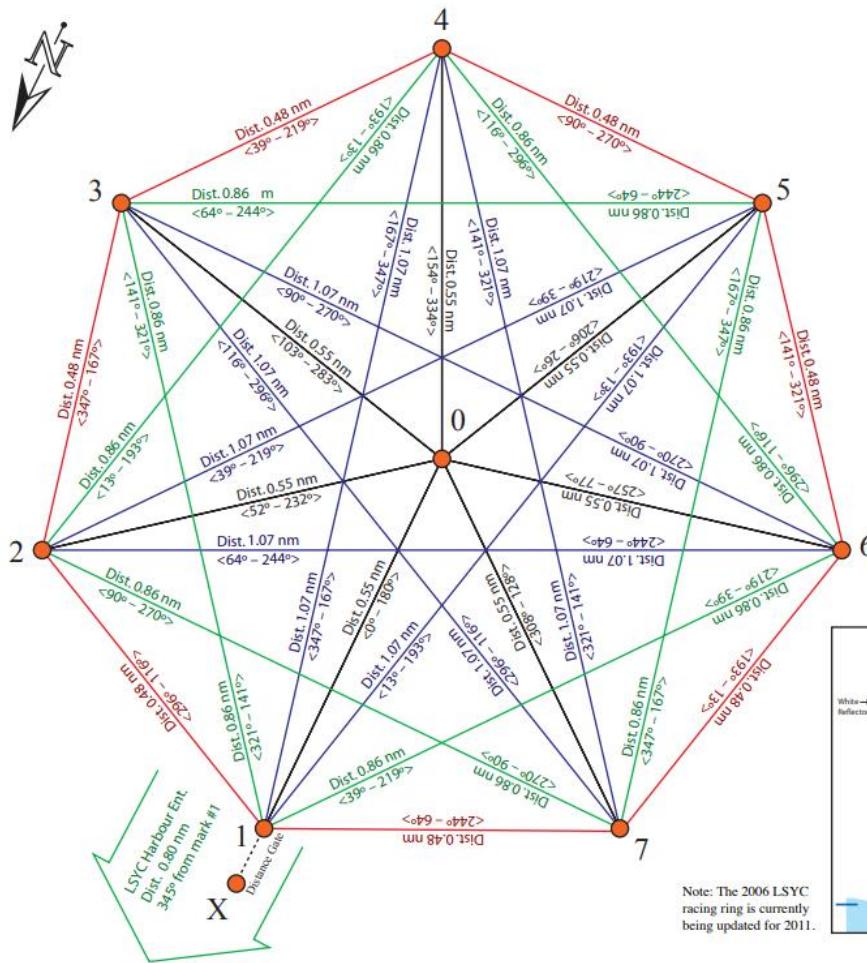
11.2 A boat that did not finish shall be awarded points for the finishing place one more than the number of finishers for that race. This changes RRS A4.2

11.3 All scoring will be Time on Time or Level.

**COMMUNICATION:**

12.1 ALL race communications will be on VHF Channel 74.

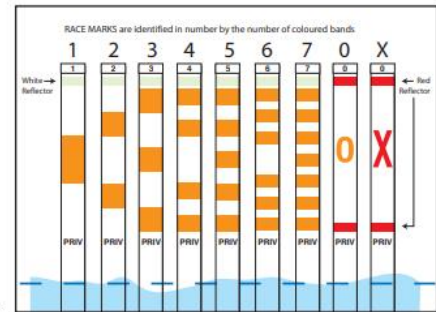
