NOTICE OF RACE

The notation '[DP]' in a rule in the NOR means that the penalty for a breach of that rule may, at the discretion of the protest committee, be less than disqualification. [NP] denotes that a breach of this rule will not be grounds for a protest by a boat. This changes RRS 60.1(a).

1. RULES

1.1 The regatta will be governed by The Racing Rules of Sailing.

1.2 The Race Committee (RC) will use a VHF radio channel to broadcast to the fleet their intentions and to announce OCS's, UFD's and BFD's. Failure to make this broadcast or failure to hear the broadcast shall not constitute grounds for granting redress. This changes RRS62.1.

2. ADVERTISING

Boats may be required to display advertising chosen and supplied by the organizing authority. [DP]

3. ELIGIBILITY AND ENTRY

3.1 The regatta is open to all monohull handicap boats, which have a valid Sail Nova Scotia PHRF Handicap and are members of a recognized yacht club and to boats of the Sonar, J/24, J/70, Farr 30, IOD and Bluenose classes who hold valid class measurement certificates and are members of a recognized yacht club.

3.2 Visiting boats may have their existing handicap (e.g. PHRF) converted using accepted formulas by the Sail Nova Scotia Handicap Committee Representative. Those visiting boats are asked to contact Kim Johnson- cycmanager@chesteryachtclub.ca- to arrange such a conversion by August 5, 2019.

3.3 Unless otherwise approved by the Regatta Chair, all classes must have a minimum of five (5) boats to be considered for a separate start. Class splits and one design fleets will be made at the discretion of the Organizing Authority.

3.4 PHRF-NS handicap boats electing to race using their PHRF-NS Non-Spinnaker Rating, PHRF-NS boats whose PHRF-NS Total Rating includes an adjustment based on a declaration of no spinnaker, and PHRF-NS boats whose PHRF-NS Total Rating is the same as their PHRF-NS Non-Spinnaker Rating are not eligible to race on the PHRF-NS Inshore Racing Course.

3.5 A boat wishing to register for the Classic Yacht Class must be a Classic Yacht as defined herein. A Classic Yacht is a Yacht launched prior to Dec.31 1994 or a replica of a classic or a boat that independently of her launch date was built in conformity with the design of a classic boat launched before December 31 1994.

3.6 The deadline for registration is 1600, August 13, 2019. Registration consists of a completed entry form, a valid PHRF handicap through Sail Nova Scotia or other jurisdiction for an out of province entry, payment of entry fees and proof of insurance in accordance with NOR 19. Registration completed after August 5, 2019 will be subject to a late registration fee of \$100 and must hold a provisional or valid Sail Nova Scotia Handicap.

4. FEES

4.1 The entry fees are as follows (all fees subject to applicable 15% HST):

On the last day of racing no warning signal will be made after 1500.

5.4 Races will be scheduled as follows:

PHRF- NS Inshore Racing Classes Up to 8 races

PHRF-NS Distance Racing Classes Up to 6 races

One Design Classes Up to 12 races

Bluenose Class Up to 12 races

Classic Class Up to 4 races

5.5 Daily Prize and Trophy presentations will take place each evening at 1800hrs, Weather conditions and protests permitting.

6. MEASUREMENTS

Each boat racing in a handicap class shall have a valid PHRF-NS Rating certificate or a provisional conversion provided by the Sail Nova Scotia Handicap Committee Representative. Each boat racing in One Design Classes shall have a valid measurement certificate.

7. SAILING INSTRUCTIONS

The sailing instructions will be made available online Sunday August 11th at 1600Hrs at www.chesterraceweek.com. Printed copies will be available at the registration desk starting on Sunday August 11. NOR 5.1 highlights available hours.

8. THE COURSES

8.1 The regatta will be sailed in and around Mahone Bay, Nova Scotia. CHS chart numbers 4381 and 4328 are the relevant charts.

8.2 PHRF- NS Inshore Racing Course will sail up to 2 races per day. The course length will depend on the conditions of the day. Some may be Windward Leeward Courses. Within the PHRF-NS Inshore Racing Course, the Race Committee will set the handicap split for each fleet and post them on the Official Notice Board no later than August 12, 2019.

8.3 PHRF-NS Distance Racing Course will sail up to 2 races per day. The course length will depend on the conditions of the day. The PHRF-NS Distance Racing Course will be sailed around fixed / inflatable marks. The PHRF-NS Distance Racing Course is open to PHRF-NS boats carrying a spinnaker and to PHRF-NS handicap boats electing to race using their PHRF-NS Non-Spinnaker Rating. PHRF-NS Total or PHRF-NS Non-Spinnaker Handicap must be declared no later than August 11, 2019 and cannot be changed for the entirety of the regatta. Boats which fail to declare their intention to race using their PHRF-NS Non-Spinnaker Handicap by the deadline will be scored using their PHRF-NS Total Handicap. Within the PHRF-NS Distance Racing Course, the Race Committee will set the handicap split for each fleet and post them on the Official Notice Board no later than August 12, 2019.

8.4 J/24, J/70, IOD, Sonar and Farr 30 Classes will race windward/leeward courses on the One Design course.

8.5 The Classic Yacht Class will sail pursuit style races.

8.6 Bluenose Class will race Windward/Leeward Races on the Bluenose Course.

9. PENALTY SYSTEM

There will be Direct Judging using Appendix U of the RRS for the Bluenose Class only, with further details to follow in the Sailing Instructions.

10. ARBITRATION

Appendix T Arbitration will apply.

11. EQUIPMENT

11.1 With the exception of the equipment requirements of one design boats which must carry the equipment mandated by their class rules, all boats, skippers and crews shall comply with the safety equipment requirements and follow the recreational boating regulations set out in the current Canadian Safe Boating Guide, or their own National regulating authority.

11.2 Boats must also carry a VHF radio, an operational compass, and a GPS on board unless stated otherwise by one design class rules. [NP] [DP]

12. SCORING

12.1 The scoring system is as follows:

12.2 One race is required to be completed to constitute a series.

12.3 For the Bluenose, One Design and PHRF-NS Inshore Courses, when 5 or more races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

12.4 PHRF-NS Distance Racing Circle and Classic Racing Circle, A boat's series score will be the total of all of her races.

12.5 PHRF-NS Inshore Racing Circle and PHRF-NS Distance Racing Circle will be scored using PHRF-NS formula time on time.

12.6 The Classic Racing class will be scored based on their pursuit race finishing order.

12.7 Corrected times will be rounded to the nearest second.

13. BERTHING & CRANE USE

13.1 Berthing or mooring arrangements are the responsibility of the skipper. Moorings will be available to rent for the week. Arrangements can be made through:

13.2 The Chester Yacht Club crane is available for registered boats that weigh less than 4000 lbs.; however, there shall be no launching or hauling from 1200 Tuesday, August 13 through 0800 on Sunday, August 18.

14. HAUL-OUT RESTRICTIONS

Keelboats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the race committee. [DP]

15. DIVING EQUIPMENT AND PLASTIC POOLS

Underwater breathing apparatus and plastic pools or their equivalent shall not be used around keelboats between the preparatory signal of the first race and the end of the regatta. [DP]

16. RADIO COMMUNICATION

Except in an emergency, or according to NOR 1.2, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile devices. [DP] [NP]

17. PRIZES

The Spray Cup will be awarded for the best performance by a first time Chester Race Week skipper. A full list of trophies will be available on the Chester Race Week website. Special prizes may be awarded as desired by the Organizing Authority.

18. DISCLAIMER OF LIABILITY

18.1 Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

18.2 Skippers must complete registration by acknowledging the waiver of responsibility during the on-line registration process.

19. INSURANCE

Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000 CDN per incident or the equivalent and shall provide proof of such to the Organizing Authority when registering. Entrants are encouraged to notify their insurance carrier of participation in this event and the rules governing it.

20. FURTHER INFORMATION

20.1 Chester Race Week is focused on implementing best practices to be a certified clean regatta. As participants, we appreciate your support and respect in maintaining our environment. This includes best practices around managing your bottle and can recycling, reducing paper and garbage, as well as preventing any waste in our waters. [NP]

20.2 Advertising is permitted in accordance with World Sailing Regulation 20. Boats that intend to display advertising must so indicate on their entry form, but there is no advertising fee. Competitors are

requested to respect the brand exclusivity of the official sponsors of this event. Their participation enhances the event for all competitors. This changes World Sailing Regulation 20.

20.3 Competitors grant the organizing authority the unrestricted right and permission to use the name and/or image for any text, photograph or video footage of either themselves or the boat they are sailing during the event to be published or broadcast in any media whatsoever (including but not limited to press and TV advertisements or internet), for either editorial or advertising purposes or to be used in press information.

20.4 The Rear Commodore of each club with boats entering the Regatta is invited to enter a team of three boats. Each boat in the team will race in different classes. The winning team will be awarded the Gordon W. Bethune Cup, and the team members will be given keepers. More information on entry will be available on the event website no later than August 1, 2019.
